Sealed Tenders (Under two part Bid system) are invited from competent ETC contractors for execution of subject works and handing over of 400 KV switchyard at Koteshwar in Uttaranchal. Only those who are technically and financially capable to execute the Job and who fulfil the Qualifying requirements [QR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The minimum QR of contractor for tender submission shall be as under:

- a) Vendors should have a minimum average annual turnover of. **Rs.52.5 Lacs** and should submit audited balance sheet and Profit & Loss Account for last three years (2004-05, 2005-06 & 2006-07 'OR' 2005-06, 2006-07 & 2007-08)
- b) Vendor should have successfully executed/executing similar job (**ref note below**) during last seven years ending 31.08.08. Vendor should produce Certification/proof in support of execution/executing similar package from User/end user and should be either of the following:
- i) **Three similar completed works each costing not less than Rs 70 Lacs.**
- OR**
- ii) **Two similar completed works each costing not less than Rs. 87.5 Lacs.**
- OR**
- iii) **One similar completed work each costing not less than Rs 140 Lacs**
- c) Vendor should have earned profit in at least one year during last three financial years (2004-05, 2005-06 & 2006-07 'OR' 2005-06, 2006-07 & 2007-08)
- d). The contractor should meet the minimum QR for T&P and testing equipments as per Annexure-I.

NOTE:

- 1. Similar job shall mean executed/ executing successfully erection, testing and commissioning of complete substation of 220 kV ratings and above.**
