SUB: EXECUTION AND HANDING OVER OF BALANCE CIVIL WORK FOR 220 KV SUBSTATION CONTROL ROOM BUILDING AT BARSINGSAR IN RAJASTHAN

Sealed Tenders (Under two part bid system) are invited from competent civil contractors for execution and handing over of balance Civil works for 220 kV substation control room building at Barsingsar in Rajasthan. Only those who are technically and financially capable to execute the Job and who fulfil the Qualifying Requirements [QR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The QR of contractor for tender submission shall be as under:

- a. Vendors should have a minimum average annual turnover of Rs. **22 lakh**. and should submit balance sheet and Profit & Loss Account for latest three years.

- b. Vendor should have successfully executed/executing similar job (s) (ref note below) during last seven years ending 30.04.08. Vendor should produce Certification/proof in support of execution/executing similar package for either of the following:
 - i. **Three similar jobs completed/ executing works each costing not less than Rs 29 lakh.**

OR

 - ii **Two similar jobs completed /executing works each costing not less than Rs. 36 lakh**

OR

 - iii **One similar job completed/ executing work costing not less than Rs. 57 lakh.**

- c) Vendor should have earned profit in at least one year during last three Financial years.

NOTE: Similar job shall mean successful completion/executing of civil works of switchyard or substation or power house.

Quotations received from bidders who do not fulfil the QR shall be summarily rejected without any further evaluation and information to bidders. Tenderers, who are not enlisted with Transmission Business Group, BHEL, should enclose all information required for a complete Evaluation & Enlistment in prescribed formats and other details as a proof of their credentials in a separate sealed envelope Superscribed " Request for Registration and enlistment" and submit prior to their offer along with Demand Draft of Rs. 1000/- in favour of BHEL, Transmission Business Group, payable at New Delhi as application fee. The enlistment format is available on Web and may be downloaded.

Important Notes

- 1) BHEL reserves the right to:
 - (a) Accept or reject any bid received at its discretion without assigning any reasons whatsoever.
 - (b) Postpone the dates mentioned in the NIT, split and distribute the work among more than one bidder without assigning any reason whatsoever.
 - (c) May ask for further qualification during techno commercial scrutiny of bids received.
- 2) BHEL shall not be responsible for any delay, loss, damage for bids sent by post.
- 3) BHEL shall not be liable for any expenses incurred by bidder in preparation of bid irrespective of whether it is accepted or not.
- 4) Canvassing i.e. soliciting favour, seeking advantage etc. in any form is strictly prohibited and any bidder found to have engaged in canvassing shall be liable to have his bid rejected summarily.
