8. BIDDERS shall ensure to indicate clearly Excise duty, Education cess, Sales Tax/VAT, Octroi, Entry tax, Service Tax as applicable for the quoted items. In the absence of clarity of these,

any claim at a later date will not be entertained. Any changes in Taxes and duties after award of the contract will not be considered except such are those, which are imposed by Govt., notification within the contractual delivery. Seeking price amendments for change in Excise duty due to crossing of turnover limits will not be considered under any circumstances.

9. TOTAL COST TO BHEL: Lowest Bid (L1) is determined on the basis of the total cost to BHEL. Total cost to BHEL = Total basic value + Packing & forwarding charges + Excise duty + Education cess + sales Tax/VAT + Freight + Insurance (as per BHEL Insurance premium) + Service Tax (as applicable) + Loading factors for deviations to commercial terms & conditions.

10. FIRM PRICE: Rates quoted should be firm and no enhancement in the rates and changes in the techno-commercial terms will be allowed once the quotation is accepted and order placed.

If pre-shipment inspection is involved, date of issue of pre-shipment call by the vendor along with test certificates / test reports / certificate of conformance / calibration reports as proof of completion will be treated as date of dispatch for penalty calculation.

In the absence of reports stated above, actual date of inspection will be considered as date of dispatch for penalty calculation.

14. TERMS OF DELIVERY: Equipment shall be delivered free at EDN / BHEL, Bangalore, inclusive of packing & forwarding charges.

Packing shall be Road / Air / Rail worthy, best suitable for transshipment and to take care of transit damages.

Dispatch the consignments through EDN/BHEL approved transporters.

Small consignments can be dispatched through M/S First Flight Couriers Ltd.

15. DELIVERY PERIOD: Indicate earliest firm delivery period in **NUMBER OF WEEKS** by which material will be dispatched from the date of receipt of purchase order. Offers such as ex-stock subject to prior sale or delivery at the earliest will not be entertained.

16. VALIDITY: Quotation should remain valid for a period of **90 days** from the due date.

17. SPLIT ORDERING: BHEL reserves the right to split the purchase based on the item wise lowest offer if the tender is not specified as a single package.

18. RISK PURCHASE: The purchaser at his discretion may also make purchase of the materials **NOT** supplied in time at the **RISK & COST** of the supplier. In this event, it will be obligatory on the part of the supplier who fails to supply the goods in time to make good to BHEL any loss due to such risk purchase.

19. BHEL reserves the right to RE-FLOAT/REJECT/CANCEL this TENDER ENQUIRY (RFQ) without assigning any reason or cause thereof. Quotes received against this TENDER ENQUIRY are subject to and governed by all these terms and conditions. BHEL's decision will be final in awarding of the contract and binding.

20. After the award of contract if BIDDER seeks dilution of the ordered specification and if such deviation is acceptable to BHEL, BIDDER shall pass on mutually agreed price reduction to BHEL.

21. POST ORDER REQUISITS:

(a) Pre-shipment inspection at your works, if required, will be done by BHEL. Required assistance to be provided at the time of pre-shipment inspection.

(b) Test certificates and warranty certificates as stipulated at the time of ordering shall be furnished.

(c) Items shall be dispatched with road/air/sea worthy packing. Any rejection due to poor packing shall be to supplier's account.

(d) Any rejection should be made good or replaced immediately.

(e) Original invoice (2 copies) to be submitted at CPD for arranging payment.

(f) BHEL is also making payment through EFT. Submit the details in the prescribed format.

22. REGRET LETTER: In case of '**NOT QUOTING**', please send **regret** letter.

23. Any dispute arising out of this shall be referred to the sole arbitration of Head of Materials Management, CE-EDN, Bangalore or any other officer nominated by him and his decision shall be final and binding on the parties. The venue of the arbitration in all cases shall be Bangalore.

24. All suits in respect of this lie in the court of Bangalore only.
