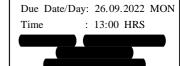

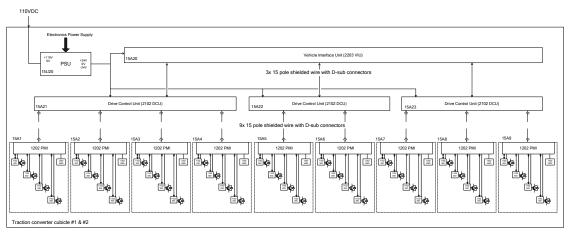

### 1.0 INTRODUCTION:

The electronics power supply is a DC/DC converter 110V / ±24VDC used to power up the control circuit of Traction Converter.

#### 2.0 FUNCTION:



The power supply receives 110V DC from the locomotive battery and generates 24V out of that for powering up the control circuit of traction converter. The Temperature classification of the electrolytic capacitors used in power supply is 105°C.

The Power Supply unit should have in-built OR-ing functionality to allow paralleling of multiple units.

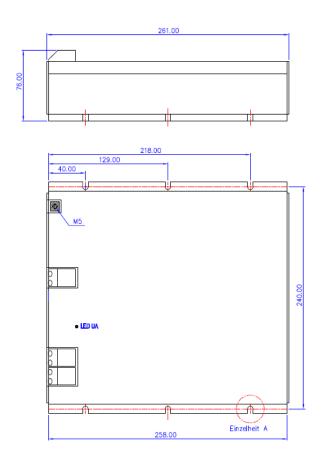
