· The offers (especially price bid) sent other than specified e-mail recipient address, including the tenderer address will call for summary disqualification.

· Techno-commercial bid will be opened first and after freezing technical & commercial conditions only, the price bid will be opened.

The quotation should be neatly typed and free from overwriting/ erasures. Any correction or addition must be authenticated. The offer including annexures and brochures should be submitted in English.

· Bid envelops shall bear the name of Bidder (OEM). In case of submission through authorized representative/agent, the name of representative/agent should be mentioned.

· Offers shall be submitted directly by bidder or his authorized representative /agent only and the offer should be in line with regulatory guidelines (i.e. Agency agreement between principal Bidder and agent / representative shall be attached which shall be a valid one and cover the scope of services rendered by Agent, Agency Commission etc.). The offers might attract disqualification if the documents are not in line with legal / regulatory guidelines. In case more than one offer is submitted (before the tender date) the latest offer would be the considered.

**5. Terms of Payment** shall be as follows:

**For Main Supply**

90% of material cost along with 100% taxes, duties & insurance will be made within 90 days from the date of receipt of complete documentation as per PO. However, payment would be done only after receipt of original documents, including site/ Customer acknowledgement on LR (MRC - Material Receipt Certificate at site). For MSMEs (covered under MSME Act) which are registered and periodically renewed with BHEL, this period will be 45 days for MSEs & 60 days for MEDIUMs.

Balance 10% material cost will be paid against submission of completion certificate of supervision of erection & commissioning of the equipment or submission of MOM for the same. Bank guarantee for the same amount i.e. 10% material cost can also be accepted.

**For Mandatory Spares Supply**

100% of material cost along with 100% taxes, duties & insurance will be made within 90 days from the date of receipt of complete documentation as per PO. However, payment would be done only after receipt of original documents, including site/ Customer acknowledgement on LR (MRC - Material Receipt Certificate at site). For MSMEs (covered under MSME Act) which are registered and periodically renewed with BHEL, this period will be 45 days for MSEs & 60 days for MEDIUMs.

**For Supervision of E&C (not applicable for mandatory spares supply items)**

100% payment along with 100% taxes & duties will be made within 90 days from the date of receipt of completion certificate of Supervision of erection & commissioning of the equipment or submission of MOM for the same. For MSMEs (covered under MSME Act) which are registered and periodically renewed with BHEL, this period will be 45 days for MSEs & 60 days for MEDIUMs.

6. Instructions to bidders (ITB Rev.12), Annexure I, II, III & IV shall be duly signed, stamped and attached with your Techno - Commercial offer, no deviation shall be allowed. Alteration /modification of the same shall lead to disqualification of the offer. May please indicate your comments separately wherever you want to deviate.

7. Qualification requirements mentioned in the PQR & technical requirements for the project must be met for consideration of offer.

8. In case of discrepancy between ITB and Supplier offer on their letterhead, ITB terms and condition will prevail except payment terms mentioned above.

9. L1 evaluation shall be on **lumpsum basis**: Cost of Main Req. + Cost of Mandatory Spare Req. + Supervision of erection and commissioning charges per number.

10. Price to be quoted as per attached enclosed price bid format only.

Indigenous Bidders: The prices are to be quoted in **INR** only on Ex works basis but inclusive of P&F, F&I upto respective project sites. GST% Extra as applicable on the date of quotation, to be quoted as percentage in the price bid.

Foreign Bidders: The prices are to be quoted on **CIP Indian Seaport/Airport** basis as per Incoterms 2020.

The Currency of offer must be **USD or EURO**. No other bid currency shall be accepted.

For bid evaluation purpose, these prices would be converted to #Cost to BHEL# based on Prevailing exchange rate as on the Technical Bid opening date.

Import duties as applicable on date of technical bid opening.

11. There shall be a multiplication factor (MF) for arriving destination cost for the bidders considering all the loading factors.

12. **There shall be no Reverse Auction for this tender.**

13. For this procurement, the local content to categorize a supplier as a Class I local supplier/Class II local supplier/Non-local supplier and purchase preference to Class I local supplier, is as defined in Public Procurement (Preference to Make in India), Order 2017 dated 04.06.2020 issued by DPIIT. In case of subsequent orders issued by the nodal ministry, changing the definition of local content for the items of the NIT, the same shall be applicable even if issued after issue of this NIT, but before opening of Part-II bids against this NIT.

14. Evaluation in case of more than one L1 bidder:

In the course of evaluation, if more than one bidder happens to occupy L1 status, effective L1 will be decided by soliciting discounts from the respective L1 bidders. In case more than one bidder happens to occupy the L1 status even after soliciting discounts, the L1 bidder shall be decided by a toss/draw of lots, in the presence of the respective L1 bidder(s) of their representative(s). Ranking will be done accordingly. BHEL's decision in such situation shall be final and binding.

15. All the prospective new bidders those who are not in the approved/registered vendor list of the BHEL Hyderabad, Pulverisers Division, will have to apply online by filling-up the vendor. Registration Format that is available on the BHEL Website (www.bhel.com) along with all the required attachments. The supplier would be qualified subject to:

a) Technical Qualification.

b) Acceptance of the commercial and other terms and conditions spelt out in the tender.

c) Final Customer Approval (if any).
