1. Type of Contract

Tender invitation- for Entering into Pre- bid tie up for Balance of System (BOS) package for development of 1200MW (2X450MW +1X300MW) grid connected Solar PV Projects at Anantapur, Andhra Pradesh.

**AWARD OF CONTRACT:** The mode of contracting with the successful bidder will be as briefly indicated below. The award shall be made as follows: The contract shall be awarded in the following manner:

**First Contract:** For supply of all plant and equipment including mandatory spares


**Second Contract:** Erection and commissioning work required for completion of project

**Third Contract:** Comprehensive Operation and Maintenance (O&M) cum CAMC for 3 years of the solar PV plant


**Fourth Contract:** 7 Years of CAMC of critical equipment beyond O&M period as per technical specification

All the above "Four" Contracts will contain a crossfall breach clause specifying that breach of one will constitute breach of the other Contract which will confer a right on the Purchaser/BHEL to terminate the other contracts. Separate Contract(s) shall be entered into for each of the blocks.
