1. The above rate quoted shall be firm for **all the model** of the cranes offered **against this tender. In case more no. of models are quoted , the lowest rate amongst the technically accepted models shall be considered.**
2. Fifty percent of the above Lumpsum Rate quoted for Mobilisation & Demobilisation Charge against Sl.No.2 will be payable against Mobilisation as defined in tender and balance fifty percent is payable against Demobilization as defined in the tender.
3. Hiring period will start from the date of commissioning and load testing of the crane at Site up to the period of last operation of the crane prior to releasing the crane for demobilizing.
4. The above quoted rates are inclusive of all taxes except service tax. Service tax (as applicable ) shall be reimbursed by BHEL extra against submission of documentary evidences to the satisfaction of BHEL.
5. In case of omission in quoting any rate, the evaluation will be done considering the highest quoted rate obtained against that item but the work, if awarded, will be on the lowest quoted rate obtained against that item as quoted by other bidders against this tender.
6. Evaluation of bids and work shall be awarded based on total price obtained against above rate schedule.

7. The bidders shall enter both 'Unit Rate' & 'Amount'. In case of any mismatch between 'Total Amount based on Unit Rate' & 'Total Amount as quoted', the higher of the two shall be considered for evaluation and the lower of two shall be considered for award.
8. The Rate shall be entered in figures as well as in words. In case of difference in rates between words and figures THE LESSER OF THE TWO will be treated as valid rate.
