SCOPE OF WORK

1. The contractor has to mobilize required competent workforce and materials to complete the work as per the requirement of BHEL. In that, Minimum **1 person** must have an **ITI qualification in Electrician** or a higher qualification in a similar electrical trade and **1 person** must hold a **B-License**.

Apart from Regular Deployment of Man power, any Additional man power as required for one time work also to be carried out with additional deployment.

2. BHEL reserves the right for extending the contract period based on the mutual agreement.
3. The quantities given on the Bill of materials against each schedule is tentative / approximate and is subject to variation before ending the contract without any compensation. There may be execution of excess quantum (or) Non-execution of any items given in the schedule (or) lesser execution of any items in the schedule.
4. The bidder shall note the clause (3) above before quoting.
5. The contractor has to execute any item of work irrespective of the quantity without any reservation till the total value of contract.
6. Water, Electricity, compressed air, MS material for small fabrication work will be provided by BHEL at free of cost.
7. No advance / mobilization advance will be given.
8. All works shall be carried out as per standard specifications and instructions of Engineer-in-charge.
9. All materials, colour, shade, brand, etc. shall be as per Instruction of the Engineer-in-charge before start of the work and shall confirm to the latest standards.
10. For Mechanical works, all Spares will be supplied by BHEL at Free of Cost. Required guidelines will be provided to carry out the aforesaid works. Any Special tools also will be provided by BHEL.
11. The contractor generally has to carry out the petty works in general shift i.e. from 8:30 hrs. to 17:00 hrs. The time may be varying according to factory operating time.
12. Factory will be operated at Round the clock for production and maintenance work. If there any urgent requirement, contractors asked to attend the work at any time including Sundays and Holidays.

14. The period of contract is two years from the date of commencement of work. And work is to be commenced as per instruction of BHEL official. The billing will be done only for executed quantities. The quantity of each item in the schedule of work may vary to any extent depends up on actual requirement. The bidders are advised to visit our factory and ascertain the working conditions before quoting.
- 15. Completion Date:** The Contractor shall complete the work specified in this contract by the agreed-upon work completion date, as stated by the BHEL in charge. PRE-QUALIFICATION REQUIREMENT

An essential qualification requirement of the contractor for tender submission shall be as under:

1. The average financial turnover of the contractor during last 3 financial years (from 01.04.2021 -31.03.2024) should be **INR 24.1 Lakhs**. While calculating Annual Turnover / Sales, other operating income and other income shall not be considered.

The bidder has to submit financial accounts (audited, if applicable comprising of Audit report, Balance Sheet, Profit & Loss A/c Statement and Notes/Schedules pertaining to Turnover/Sales/Revenue), for 3 years (or from the date of incorporation, whichever is less) as on tender due date to review the above criteria. In case the incorporation of vendor is less than 3 years, average annual financial turnover shall be calculated based on available information as below: -

- a) If the accounts are available for ≤ 1 Financial Year, the Average Annual Turnover shall be calculated based on available information divided by 1 (One).

2. INSTRUCTIONS TO BIDDER

1. **Bidders have to submit their offers through BHEL e-procurement portal (<https://eprocurebhel.co.in/nicgep/app>) only.**
2. **The tenderer should quote the total lump sum amount for complete scope of work and BOQ excluding GST. Individual item rates for the all BOQ schedules will be arrived based on the lump sum amount quoted by the bidder & % percentage weightage indicated against each schedule. This amount shall be rounded off to the nearest Rupee.**
3. "No interest shall be payable by BHEL on EMD/ Security Deposit, if applicable, or any money due to the contractor by BHEL".
4. "BHEL shall have the right to recover any money due from the contractor from any money due to the contractor under this contract or any other contract or from the security deposit".
5. Should a tenderer or a contractor has a relative or in the case of a firm or company of contractors, any of its shareholders or shareholder's relative, employed in Bharat Heavy Electricals Limited, the authority inviting tenders shall be informed of this fact at the time of submission of the offer, failing which the offer may be disqualified or if such fact subsequently come to light, the contract may be cancelled.
6. BHEL employees and their dependents are NOT eligible to submit their offer against this contract. Even if they submit out of ignorance, the offer shall be disqualified.
7. If the contractor deliberately, gives wrong information in his tender or creates conditions favourable for the acceptance of his tender, Bharat heavy Electricals Limited reserves the right to reject such tender at any stage.
8. Canvassing in any form in connection with the tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
9. The tender documents must be signed physically / digitally by Director / Partner of the Firm or by the person holding the Power of Attorney on behalf of the Firm concerned. In the latter case, a copy of Power of Attorney, duly attested by a Notary Public must accompany the tender.
10. **The tender schedule and the tender shall be deemed to form an integral part of the contract to be entered into for this work.**
11. Tender can be cancelled at any stage due to unavoidable circumstances.
12. The evaluation currency for this tender shall be INR.
13. Multiple Bids: -

The bidder in his own interest shall submit only one id. If a bidder submits multiple bids, all the bids are liable for rejection. Bids shall be considered "Multiple" in the following circumstances:

“Person” for the purposes of this definition shall mean any natural person, individual, corporation, limited partnership, co-operative, general partnership, joint stock company, joint venture, association, company, trust bank, trust company, land trust, business trust, corporate body or other organization, whether or not a legal entity.

14. Offers of the Contractors/Suppliers, against whom, any unit of BHEL had initiated process for “Suspension of Business Dealings” or already done will summarily be rejected.
15. If at any stage, the document(s) submitted by contractor is/are found incorrect/ false/ manipulated, the necessary action will be taken by BHEL against contractor as per the “Guidelines for suspension of Business dealings”.
16. **Suspension of Business dealings with Suppliers:**

Any supplier against whom action has been initiated under “suspension of business dealings with suppliers” are not qualified to participate in this tender. Before submitting offer, prospective bidders are advised to visit our web-site www.bhel.com / supplier registration to familiarize themselves with BHEL’s policy and procedures of Suspension of Business Dealings with Suppliers. Submission of offer shall be deemed to be evidence of the Bidder to have read and understood the above said policy.

17. **Treatment of Debarment / Under-performing Vendors:**

Any supplier who has been put on “Debarment” from having business dealings with BHEL, Ranipet or any other unit of BHEL shall not submit their offer against this tender. If any such offers are received they would be summarily rejected and sent back. During the processing of tender, if any unit of BHEL puts a supplier on “Debarment” then further processing of the offer will not be taken up and in case an order is placed, BHEL, Ranipet may resort at their discretion to cancel the PO either fully or partially.

18. In quoting the rates, the tenderers are advised to take into account of all the factors including any fluctuations in the market rates etc. No claim shall be entertained on this account after acceptance of the tender or during the currency of the contract.

19. **QUOTING: Bidders have to submit their offers through BHEL e-procurement portal only. The tenderer should quote the total lump sum amount for complete scope of work and BOQ excluding GST. Price bids of all techno-commercially qualified bidders shall be opened and same shall be considered for RA. In case any bidder(s) do(es) not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking."
25. **The rates quoted in the tender shall remain valid for a period of three months from the date of technical bid opening for acceptance by BHEL.** No unsolicited revision in the tender offer shall be entertained after opening of tenders and till expiry of the validity period.
26. Any deviation to this tender terms & conditions and schedules of this tender will lead to total rejection of the offer submitted.
27. The bidders shall closely pursue all the clauses and specifications indicated in the tender documents before quoting. Should the bidder have any doubt the meanings of any portion of the tender specification or find discrepancies or omission in the drawings or the tender documents issued are in complete or shall require clarification on any of the technical aspect, scope of work etc., he shall at once contact the authority inviting the tender for clarification before the submission of the tender.

33. **Clause in case of Tie:**
“In the course of evaluation, if more than one bidder happens to occupy L-1 status, effective L-1 will be decided by soliciting discounts from the respective L-1 bidders. In case more than one bidder happens to occupy L-1 status even after soliciting discounts, L-1 bidder shall be decided by a toss / draw of lots, in the presence of the respective L-1 bidder(s) or their representative(s) - If available, otherwise the same procedures will be carried out to arrive for L1 ranking) Ranking will be done accordingly. BHEL’s decision in such situations shall be final and binding.’
34. BHEL reserves the right to reject any tender on the basis of unsatisfactory performance of the bidder in any ongoing job or any similar job in the past.
35. Possession of PF registration number is not mandatory. However, the successful tenderer has to register with PF authorities and furnish the registration number before first Running Account Bill.
36. Incomplete offers shall become liable for rejection.
37. All entries in the tender documents should be in one ink. Erasures and over-writings are not permitted. All correspondences and insertions should be duly signed by the tenderers concerned.
38. **Tenderer has to put sign and seal at the bottom right side in all the pages of tender documents and also supporting documents.**
39. **The tenderer should fill and sign the “checklist of this Tender document” which forms part of the technical bid.**
40. Conditional tenders, tender containing absurd rates and amounts, tenders which are incomplete or otherwise considered defective and tenders not in acceptance with the tender conditions laid down by the Accepting Officer, are liable for rejection.
41. If a tenderer expires after submission of his offer, the Bharat Heavy Electricals Ltd., may be at their discretion to reject such offer.
42. BHEL reserves the right to negotiate with L1 bidder.
43. - b) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
 - c) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (a) and (b) above.
 - d) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.

49. If a ring formation is suspected, BHEL may reject all offers or retender or call new sources who have not been contacted or responded against this tender.
50. If a tenderer withdraws his offer after submission or after acceptance, fails to provide the sufficient manpower to carry out works in accordance with the instructions of the user department or any other official designated by them, acceptance of his tender will be withdrawn.
51. The applicable GST (as quoted by the tenderer / limited to applicable tax, whichever is lesser) can be claimed from BHEL along with their bills for further payment to be made for the authorities concerned. In case of reverse charge applicability, BHEL will not reimburse to the tenderer the reverse charge of GST paid by BHEL.
52. The tenderer, while quoting rate, take into the account the likely expenditure in complying with statutory compliances like PF & ESI contribution, Minimum Wages, Bonus, Holiday & EL wages including related laws and the expenditure. SPECIAL TERMS AND CONDITIONS OF THE CONTRACT

1. The contractor has to bring adequate manpower for carrying out and completion of the daily activities/works that are assigned by the concerned department Officials specified in the Tender Schedule. The manpower may be increased or decreased depends upon quantum of work. If the Contractor is not completing the assigned work in time as specified by BHEL, the same will be completed by BHEL engaging alternate resources and the difference in rate of payment with BHEL overheads will be debited/recovered from the Contractor. If such instance repeats frequently it will be viewed seriously. Whenever there is an additional requirement is communicated by the BHEL Officials, as per the need, the contractor should provide the additional manpower to carry out the work in time.
2. This work shall be in force for Two Years from the date of commencement of work. The period of the contract may be renewed or extended at the discretion of Bharat Heavy Electricals Limited.
3. The contractor will have to plan this work accordingly. Quantities shown in the attached schedules are indicative only and they are liable to vary depending upon the shop production. Any claim on account of variation of quantity will not be entertained. The period of contract may be extended on mutual agreement.
4. The contractor shall be solely responsible for the safe custody for the materials from the time the materials are handed over to him till the materials are delivered at the places specified and will indemnify the Bharat Heavy Electricals Limited against any loss, damage, breakage, shortage and pilferage of any materials while in his custody.
5. In case of any neglect or refusal on the part of the contractor to provide sufficient labour for the aforesaid work or if in the opinion of Officer-in-charge, the services provided by the contractor are not satisfactory, the Officer-in-charge shall be at liberty to make such arrangement as he may deem fit at the cost and expense of the contractor. The contractor shall be advised of the amount so incurred and he shall be bound to remit the sum within three days from the date of receipt of such advice. Failure to do so will entitle the Officer-in-charge to deduct the sum from the money due to the contractor.
6. The contractor shall either supervise the work or provide sufficient supervisors to supervise the work of his staff. The supervisors employed by the contractor shall ensure proper outturn of work and discipline is maintained by the labours and in general to see that the works are carried out in a safe and proper manner.
7. BHEL will not be responsible for the idle labour of the contractor for whatever reasons.
8. Should any error or ambiguity be discovered in the specification or information, the contractor shall forthwith bring the same to the notice of Bharat Heavy Electricals Limited before commencement of work. The BHEL's interpretation in such cases shall be final and binding on the contractor.
9. In case of any loss to Bharat Heavy Electricals Limited, caused due to stoppage of work without sufficient reason or damage to any equipment or components or any property thereof, due to the negligence and carelessness of the contractor's men, the responsibility shall rest with the contractor. The actual cost of the loss or damage together with the overhead will be recovered from the contractor's bill. The decision of BHEL regarding the cost of loss as well as the extent of cost of damage shall be final and conclusive.
10. The Contractor shall be present at the work spot daily and the work shall be carried out under direct supervision of the contractor. However, in his absence, authorized

representatives/agent shall be available for receiving instructions and to carry out the work under proper supervision. The work shall not be sub-contracted / delegated.

11. Work carried out by BHEL on overlapping areas shall not be included in the claim and any deviations to this will be viewed seriously and treated as a violation to the contract.
12. The minimum safety equipment's required to be provided for the contractor's workmen under this contract are safety boots, leather hand gloves, welding screen, welding/cutting goggles and apron. It is the responsibility of the contractor not only to provide the work force with such safety equipment's at their cost as may be considered necessary for the execution of the work but also to ensure their wearing the above safety appliances, failing which corrective action will be taken by withholding the amount recommended by BHEL /Safety Officials for each violation, which may be released only after compliance of the same. 18. The contractor has to ensure payment of the statutory prescribed minimum wages as applicable from time to time and maintain proper records of their timely disbursement. These records would need to be preserved and made available even after the contract is over for any verification by the various statutory authorities.

- 26. BHEL will not bound by any power of Attorney granted by the tenderer or changes in the composition of the firm made subsequent to the execution of the contract. The balance scope shall be got done independently without Risk & Cost of the failed supplier/ contractor. Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.

30. POST TECHNICAL AUDIT OF WORK AND BILLS: -

BHEL reserves the right to carry out the post-payment Audit and technical examination of the work and final bill including all supporting vouchers, abstracts etc., and enforce recovery of any sum becoming due as a result thereof in the manner provided in the presiding sub-paragraphs. However, no such recovery shall be enforced after three years of passing the final bill.



