

SAS/ RATE CONTRACT/03 – CORRIGENDUM- 01

1. In all turbine packages A to D, in optional package regarding crane operators (Page 1, 2, 3 and 4), it is wrongly mentioned as **per day basis**. This is proposed to be changed to **“Providing EOT crane operators for round-the-clock operation for entire duration of the job”**.
2. In scope of work for 200 MW LMW Design, **Schedule A, F and I** shall combinedly form the Package of **“General Overhauling Activities”**, for which **14%** is allotted in the break-up. **Schedule E, G, H, J, K, L and M** shall combinedly form the package of **“Valves”**, for which **15%** is allotted in the break-up. Other packages are **Schedule B (HP – 18%), Schedule C (IP – 18%), Schedule D (LP – 15%) and Schedule K (Generator – 20%)**.
3. In SCC, in the Section **05-C** dealing with **Finalisation of Rate Contract and Allocation of Job**, in Point b-2, it is mentioned that “If the vendor skips two jobs, they will not be considered for that category of jobs in that region for **that year**”. This is proposed to be changed to “If the vendor skips two jobs, they will not be considered for that category of jobs in that region for **the entire duration of the rate contract**”.
4. In the Format for vendors, it is wrongly mentioned to provide the details of jobs carried out in the last **five** years. This is proposed to be made to last **seven** years.
5. As pointed out by M/s Chemclean Services, mobilization period of 3 days is not feasible for chemical cleaning job as lot of machinery, piping and chemicals are to be arranged and transported to site. It is proposed to be increased to **7 days**.
6. In point no. 9 of “essential conditions to be fulfilled by successful bidder during execution” (Page 10 of SCC), requirement of calibration certificates for electric welding generators and arc welding transformers is proposed to be deleted as there no certification agencies for these items.
7. The value of **Performance Bank Guarantee** as per **Clause 05-A**, is given as Rs. 5 lakhs for all A to K. This is proposed to be reduced to **Rs. 2 lakhs** for **Package E (Provision of Expert Manpower), Package F (Chemical Cleaning), Package G (Overhauling of APH), Package H (Electrical / Diagnostic Tests), Package I (Vibration Analysis) and Package J (Thermal Insulation of Turbine)**, as there is no assured business in these areas and the volume of business is also very less.
8. **FUNCTIONS AND RESPONSIBILITIES OF PERSONS DEPUTED TO SITE AND TERMS AND CONDITIONS FOR DEPLOYMENT ODF EXPERT MANPOWER TO SITES**
 - A. **Functions and Responsibility of Specialists at Site**
 - a. Technical Supervision of the site work and planning of the job incl. day-to-day execution.
 - b. Coordination with the customer regarding technical aspects & planning of spares.
 - c. It will be the responsibility of the specialist to get the work done by the agency at site.
 - d. The specialist shall be responsible for quality of work at site and time schedule of the assignment. He shall maintain a diary recording date-wise work performance at site.
 - B. **Terms & Conditions**
 - The daily rates refer to a normal working time of 8 hours a day and 6 days per week. However, exigencies of work may demand stay up to 12 hours in a day and no additional charges shall be payable for the same. Sundays and Public Holidays shall

- be treated as paid holidays. Deployment beyond 12 hrs and deployment on Sundays & holidays shall
- be payable additionally on pro-rata basis. The hourly rate for this shall be calculated by dividing daily rate by 8.
- The payment shall be made for the period of stay at site.
- Service tax shall be payable extra as per applicable rates.
- To and fro travelling expenses by rail/road shall be payable restricted to maxi. of AC II fare from place of start on certification & mentioning the PNR no. of train ticket. Any other mode of transport shall be undertaken with prior permission, at the discretion of BHEL.
- Person deputed to site shall be provided with suitable furnished bachelor accommodation free of cost by BHEL.
- Emergency medical facilities as available at site/ place of stay will be provided free of charge.
- Payment shall be released monthly on the basis of attendance certification from site on submission of bill duly supported by time sheet.
- Local transport from place of stay at site to the work place shall be provided by BHEL.
- The person deployed to site shall generally remain unchanged for the complete duration of the job. However, in case of emergency, one change shall be permitted and suitable replacement shall be given by the service provider. At the discretion of BHEL, break at site shall be permitted.
- Before deployment to site, bio-data mentioning qualifications/experience, etc. of prospective persons shall be submitted by service provider for the acceptance of BHEL. The acceptance or rejection of the personnel shall be at the sole discretion of BHEL.
- All statutory requirements including insurance are to be fulfilled by the party at no additional cost to BHEL. Compensation liability on account of any accident / eventuality shall not be borne by BHEL.
