1. Material shall be directly supplied to BHEL Rudrapur, rates shall be quoted FOR BHEL RUDRAPUR basis including transit insurance and freight charges. (Address: CFP-BHEL Rudrapur, Kichha Bye Pass Road, Near FCI Godown, U.S. Nagar, Uttarakhand-263153).
2. **Rates shall be based on FIRM basis.**
3. **QUOTATION VALIDITY:** 90 days from the date of bid opening.
4. Bidder has to submit the HP authorized partner certificate for supplying of HP Toner consumables" else offer will be rejected summarily.
5. **Pre-qualification Requirements shall be as per Annexure-A. Relevant documents must be furnished for PQR qualification.**
6. Tender shall be awarded to techno-commercially qualified bidder who quotes lowest landed rate in price bid/finance bid on item-wise basis.
7. Taxes & Duties etc. shall be payable extra at actuals. Bidder has to separately mention applicable taxes in attached **Tax. Sheet.**
8. Bidders to submit signed and sealed copy of all attached NIT documents and Standards as a proof of acceptance.
9. **Delivery shall be within 30 days from the date of Purchase order**
10. **PAYMENT TERMS-** 100% payment shall be made within 45 days after receipt and verification of material at store subject to acceptance. Any deviation in payment terms will be loaded (SBI PLR rate at the time of tender opening + 6 %) annual interest rate for sought relaxation time period for bid opening)
11. **Reverse Auction clause is not applicable for this tender.**
12. In case of any deviation to delivery schedule, as mentioned in NIT delivery loading @0.5% per week, max. 10% shall be imposed on quoted price for comparing L-1 standing.
