1. SCOPE OF SUPPLY:

2. DELIVERY TERMS:

Material shall be supplied on FOR BHEL RUDRAPUR. Therefore, rates to be quoted on FOR RUDRAPUR BASIS only including packing, forwarding, freight & insurance, Installation & Commissioning.

Tender shall be awarded to techno-commercially qualified bidder who quotes lowest landed rate in price bid/finance bid.

3. TAXES AND DUTIES:

TAXES & DUTIES etc. shall be paid extra at actual on submission of documentary evidence.

4. PRICE BASIS:

Prices shall remain firm till the execution of the contract.

5. QUOTATION VALIDITY:

90 days from the date of bid opening.

6. ACCEPTANCE OF TECHNICAL SPECIFICATION:

Bidder to submit signed and stamped copy of Annexure-A (**BOQ & Specifications**) and all other TENDER DOCUMENTS as a proof of acceptance of technical and commercial terms.

7. DELIVERY SCHEDULE:

Supply, Installation, Testing & commissioning shall be completed at BHEL Rudrapur within **03 weeks from PO date** and in case of any deviation in delivery terms, loading on offer will be done (0.5 % per week, maximum up to 10 %) for comparing L1 standing

9. PAYMENT TERMS:

Payment will be done within 45 days of installation of all items. subject to submission of installation report and submission of performance Bank guarantee @10 % of PO value.

ANY DEVIATION IN PAYMENT TERMS WILL BE LOADED (SBI PLR RATE AT THE TIME OF TENDER OPENING + 6 %) ANNUAL INTEREST RATE FOR SOUGHT RELAXATION TIME PERIOD FOR COMPARING STANDING

10. PERFORMANCE BANK GUARANTEE:

Supplier has to submit performance Bank guarantee @10 % of PO value from the date of acceptance by BHEL. PBG shall be furnished in a prescribed format and from one of the consortium banks of BHEL. PBG shall be valid up to 30 days beyond warranty/guarantee period

11. REVERSE AUCTION:

No reverse auction (RA) shall be conducted for this tender.

12. LIQUIDATED DAMAGE (LD):

In case of delay in delivery, a penalty of 0.5% per week, maximum up to 10% of total order value on delayed portion shall be applicable. In case of quoting any deviation from the above LD clause, the offer shall be loaded in comparison statement for un-accepted portion of LD, maximum up to 10% of basic value.

13. RISK PURCHASE CLAUSE:

If the supplier fails to deliver the whole or any part of the goods or services within the stipulated delivery period mentioned in the Purchase order, BHEL shall be entitled to terminate the contract and to purchase the same or the best and the nearest available substitute from elsewhere at the risk and cost of the seller either the whole or any part of the goods/Services.

In case of deviation or non-acceptance of Risk Purchase clause, offer shall be liable for rejection.

14. SUSPENSION OF BUSINESS DEALINGS:

Action shall be taken as per extant BHEL "Guidelines for Suspension of Business Dealings with Suppliers/Contractors AA/MM/SB/01 Rev.02 Dated 22.07.2016" against Supplier as well their agents who either fail to perform or are in default without any reasonable cause like force majeure, cause loss of business/money/reputation, indulge in malpractices, cheating, bribery, fraud or any other misconduct or formation of cartels so as to influence the bidding processor influence the price, tempering with tender process etc. Further details in this regard can be accessed through BHEL website www.bhel.com
