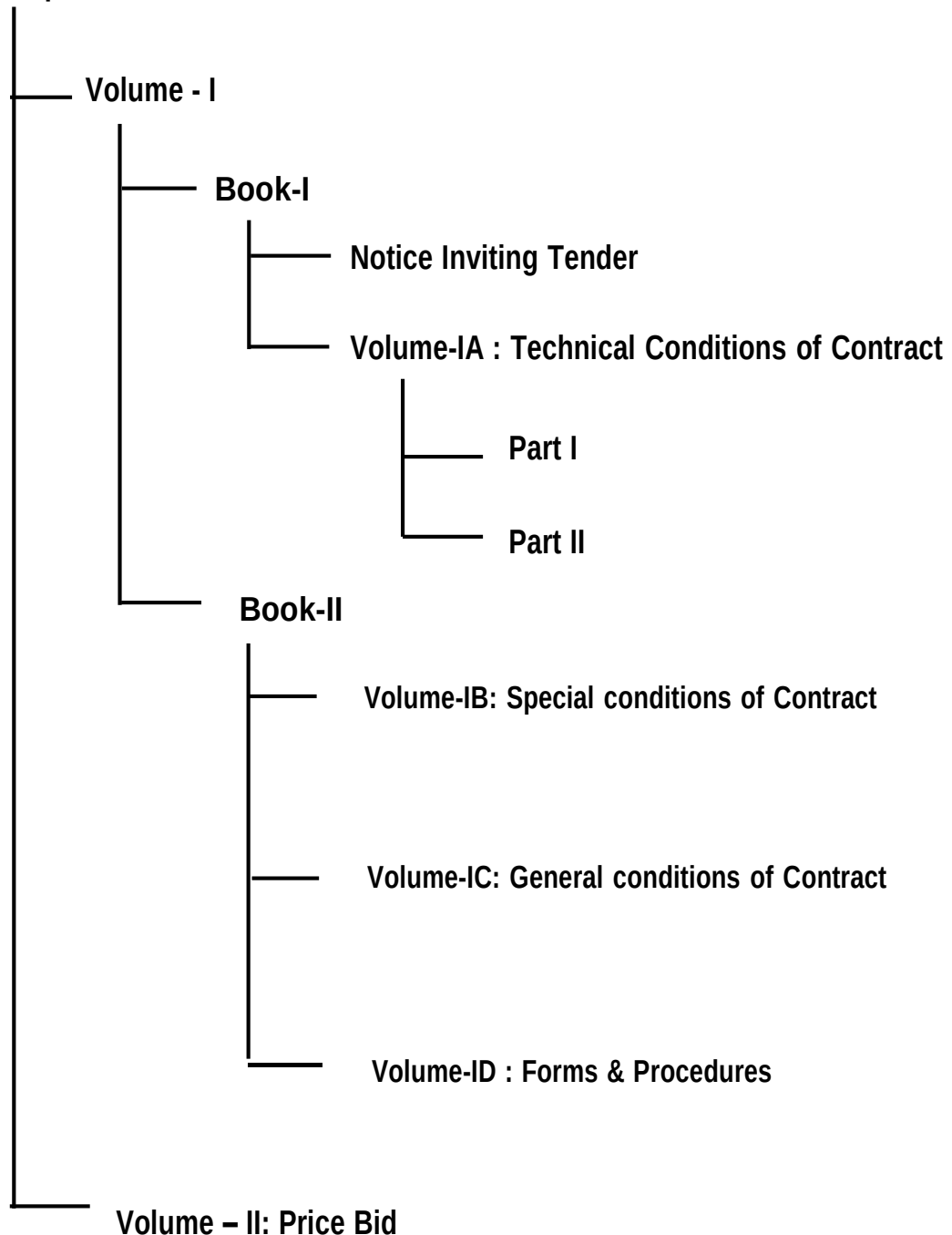

PART A

Instruction to Bidders:

1. Tenderers are requested to affix their company seal and authorized signature in all pages.
2. Bidders shall quote 'Total Amount' in the format enclosed as a separate Excel File in BHEL NIC e-Procurement portal for the subject tender and upload the same under 'Packet details - > Tender covers -> Finance '(Cover Type Description – Price Bid)' and same shall be taken into account for evaluation and awarding and hence, shall be complete in all respect for the full scope of work defined in specification and in accordance with terms & conditions of the tender. Any other entry elsewhere in the price bid shall be treated as Null and Void. Quoting of rates in any other form/formats will not be entertained.
3. Instructions to Rate schedule mentioned in Chapter –VIII of TCC shall be referred to by the bidders before quoting.
4. The above mentioned 'Total amount' is for the entire Bill of Quantity (BOQ) given in Part -C of the Price Bid.
5. BHEL has pre-fixed the weightages for the amount of individual items of Bill of Quantity with respect to the 'Total Amount' in Part C of Price Bid.
6. Based on the pre-fixed weightages, the amount for the individual items of the Bill of Quantity shall be arrived at. This amount shall be rounded off to the nearest rupee.
7. Monthly Hire Charges shall be as per the "Rate/Month" arrived against Sl. No. 1 in Part-C.
8. Mobilization and De-Mobilization Charges shall be as per the rates arrived against Sl. No. 2 and Sl. No 3 in Part-C respectively.
9. The rate quoted shall be firm for the Crane offered against this tender throughout the contract period and no price variation provisions are applicable.
10. In case of extension period, if any, the Monthly Hire Charges shall be 90% of the monthly hire charges agreed for the regular contract/hiring period. No extra changes will be made for mobilization & Demobilization for the extended period .
