

PART-A-INSTRUCTIONS TO BIDDERS:

- 1) Bill of Quantities for package A is indicated as "Part C: Bill of Quantities, Tender Specification BHEL:PSSR:SCT:1945A" and Bill of Quantities for package B is indicated as "Part C: Bill of Quantities, Tender Specification BHEL:PSSR:SCT:1945B".
- 2) Bidders shall quote 'Total Amount for Package A' in the format enclosed as a separate Excel File in BHEL NIC e-Procurement portal for the subject tender and upload the same under 'Packet details - > Tender covers -> Finance '(Cover Type Description – Price Bid)" and same shall be taken into account for evaluation and awarding and hence, shall be complete in all respect for the full scope of work defined in specification and in accordance with terms & conditions of the tender. Any other entry elsewhere in the price bid shall be treated as Null and Void. Quoting of rates in any other form/formats will not be entertained.
- 3) The above mentioned 'Total amount' is for the entire Bill of Quantity (BOQ) for Package-A given in Part -C (BHEL:PSSR:SCT:1945A) of the Price Bid. BHEL has pre-fixed the weightages for the amount of individual items of Bill of Quantity with respect to the 'Total Amount' in Part C of Price Bid. Based on the pre-fixed weightages, the amount for the individual items of the Bill of Quantity shall be arrived at. This amount shall be rounded off to the nearest rupee.

- 4) The successful bidder against this quote will be awarded the contract for Package A.
- 5) The finalized contractor for Package A will not be eligible for Package B.
- 6) The ratio of total amounts for Package A: Package B is 1:1.033.

This amount arrived at shall be rounded off to the nearest rupee.

- 7) The value of Package B thus arrived at *is the lump sum amount* for the entire Bill of Quantity (BOQ) for Package-B given in Part -C (BHEL:PSSR:SCT:1945B) of the Price Bid and shall be offered to the next lowest bidder in the order of competitiveness i.e., L2, L3 and so on till H1 in that order, for matching.
- 8) BHEL reserves the right to not award Package B in this manner at its sole discretion, without furnishing any reason to the Bidders.
- 9) The price quoted by the bidder shall be for the scope of work as detailed in relevant chapters of Volume IA Technical Conditions of Contract.

- 10) In case BHEL at its discretion opts to go for re-tendering for award of work of Package B, then the Bidder who is awarded with the work of Package A shall not be considered for award of Package B.
