

PART A

Instruction to Bidders:

1. The lump sum price shall be quoted by the bidder for the entire scope of work as detailed in relevant chapters of Volume IA Technical Conditions of Contract.
2. Bidders shall quote 'Total Amount' in the format enclosed as a separate Excel File in e-Procurement portal for the subject tender and upload the same under 'Packet details -> Tender covers -> Finance '(Cover Type Description – Price Bid) and same shall be taken into account for evaluation and awarding and hence, shall be complete in all respect for the full scope of work defined in specification and in accordance with terms & conditions of the tender. Any other entry elsewhere in the price bid shall be treated as Null and Void. Quoting of rates in any other form/ formats will not be entertained. The quantity indicated in the BOQ / Price bid (Part C) is approximate only and is liable for variation. Payment will be as per actual quantity executed as certified by BHEL Engineer.
3. The above mentioned 'Total amount' is for the entire Bill of Quantity (BOQ) given in Part-C of the Price Bid.

Note:

1. The 47.1554 % of the Bidder's quoted total amount value shall be allocated towards the deployment of T & Ps and the balance 52.8446% shall be allocated for the works and other services like manpower, T& Ps other than cranes (like Jacks, Sleepers for unloading by Rigging method etc.) and trailer etc. Bidders are to note that Only the value of this 52.8446% will be taken into account for the purpose of quantity variation, Over run compensation and Price variation clause.
2. The percentage of allocation per month per item to be considered for the purpose of payment for the cranes and trailers deployed is mentioned against each T & P.
3. There shall be no separate charges for re shifting and restacking of materials. Any number of times Re shifting / Restacking is required for upkeep of MM, Bidder shall carry out the same within the quoted lump sum price.
4. Bidders are requested to note the following clauses of Technical conditions of contract (volume-IA Book –I).
 - 4a. Clause 1.4.2 on submission of BGs and also
 - 4b. Clause 1.4.11 on engaging The T&Ps for other BHEL jobs.
 - 4c. Chapter VII on penalty clauses.
 - 4d. Chapter IV - Clauses on deployment of T & P and recovery for non-compliance.
