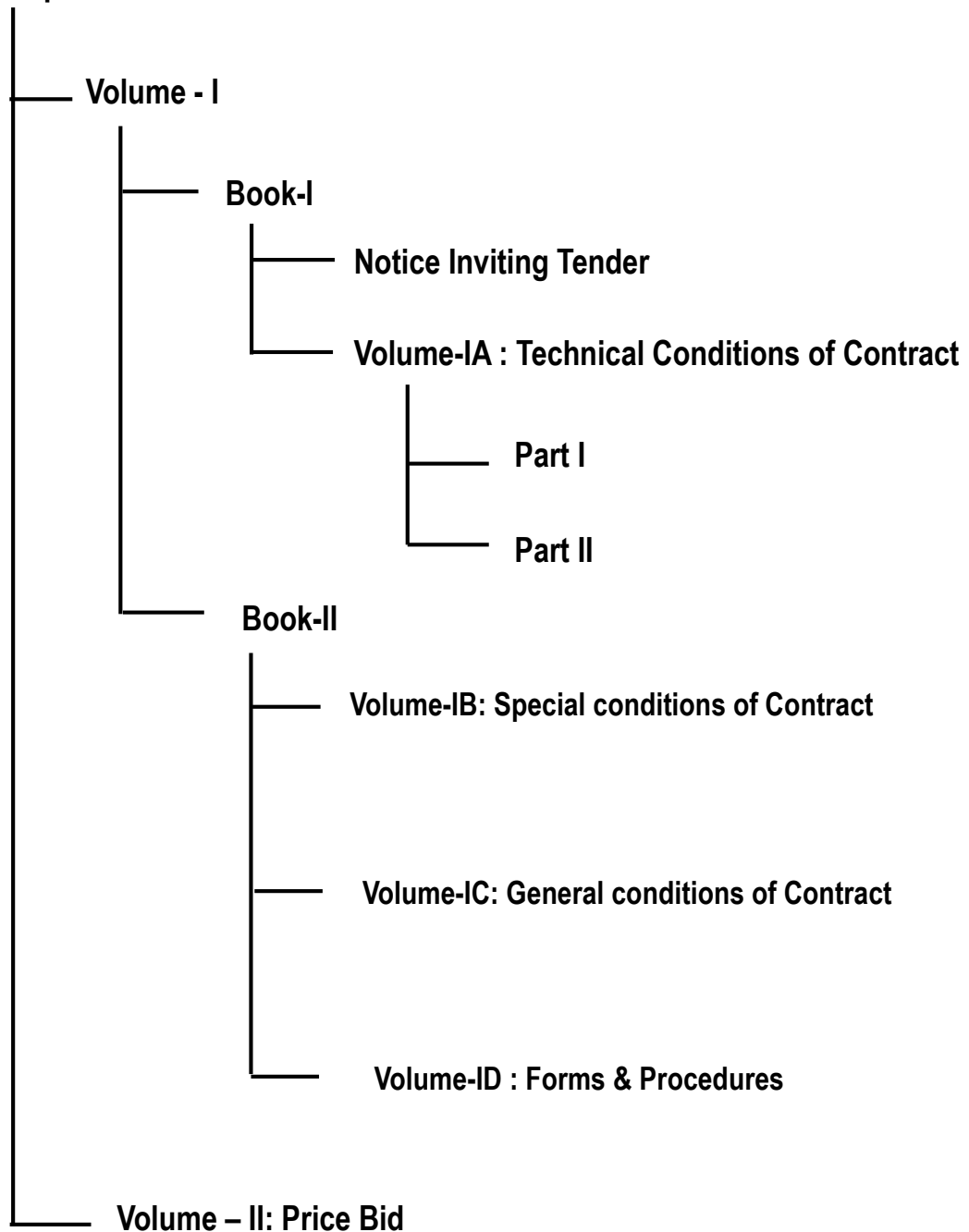

PART A

Instruction to Bidders:

1. **Percentage (%) of Service Charge**, over and above the **applicable monthly statutory minimum wages**, shall only be quoted by the bidder, for providing the services of manpower (one Operator, one Maintenance Personnel and one Helper) for regular operation & routine maintenance of **One Crane of Specific Category** (i.e. Cat-I / Cat-II / Cat-III / Cat-IV) in the format enclosed in Volume-II - Price Bid. Service Charge quoted in any other manner will not be accepted.
2. Bidder may choose to quote against any or all the categories of cranes. However, quoting for a particular category shall mean bidder's acceptance to provide services for cranes of all the capacities within that particular category.
3. Evaluation shall be done separately for each category based on the Percentage (%) value of Service Charge quoted by bidders for the respective category in the enclosed Excel File.
4. Successful bidder(s) in any category shall also be considered for other categories subject to fulfilment of Pre-Qualification Criteria.
5. For further details on Mode of Award of Contract Bidder to refer Clause 35.0 of NIT.
6. Percentage (%) value of Service Charge quoted by the bidder shall remain FIRM during the entire Contract Period of 2 years (and during extension period of up to 3 months, if applicable) and will not be subjected to any escalation whatsoever during the validity of this contract. However, the absolute cost may vary as per the bill value on all-inclusive basis.
7. Percentage (%) value of Service Charge quoted by the bidder is inclusive of all the payments to the CONTRACTOR's resources, statutory liabilities like labour license, adequate insurance policy, provident fund, Bonus, profits and any other charges (including but not limited to as mentioned herein / after) that may be incurred during execution of this contract.
8. GST as applicable will be paid extra by BHEL
9. Bidders may please refer to Part-C (Proposed Pay Elements) of this Price Bid - Rate Schedule before quoting. The Descriptions mentioned (**Sl. No.3 to Sl. No.6**) in Volume-II Price Bid - Part-C (Proposed Pay Elements) and the rates mentioned against each of them are only for **illustrative purpose**, based on the weighted average of rates applicable at different states, where the cranes are presently available. However, the Minimum wages with VDA and other Statutory components shall be as per the applicable state/central wages of the respective site, where the O&M services is to be provided.
