

Corrigendum 2 dated September 29, 2022 to Tender Specification BHEL: PSSR: SCT: 2044 for Providing Safety Management services along with manpower for strengthening of Safety Culture and effective implementation of Health, Safety and Environment Management system at Yadadri, Udangudi & Ennore-SEZ project Sites

A. The following Clause 20.A is added in the Notice Inviting Tender:

20.A It shall be mandatory for the successful bidder(s) to be registered on GeM and have a unique GeM Seller ID before the placement of order. The aforesaid GeM Seller ID shall be incorporated in the order issued by BHEL.

B. Some of the Bidders had asked queries in the published Tender Specification. BHEL clarifications are furnished below:

However, deployment of manpower will be done in a phase-wise manner. Request you relax the criteria for the same from 15 days to 30 days.	Tender conditions prevail.
