1. Enquiry No., due date etc. must be legibly super scribed on the sealed envelopes as per clause no. 2.0 of "Instructions to Bidders" of GCC, Rev. 06.
2. Offers should be submitted in two parts i.e. in two separate sealed covers as follows:

9. Late tenders will be rejected.

10. **INSTRUCTIONS REGARDING CENTRALISED TENDER ROOM:**

- a) Vendors are advised to submit the tenders in the tender box, containing Part-I & II offers in separate covers, preferably cloth lined envelopes should be used, properly marked before due date and time.
- b) The dispatch department shall not accept any tender in torn condition and return the same to the courier immediately with the Stamping "Returned to Sender-Package Damaged". Offers in damaged condition will not be considered and no request for extension on this account will be considered.
- c) Bidder's representative shall deposit the offer in tender box only.
- d) Bidders shall be allowed in the tender room in area identified for bidders and only one authorized representative from each bidder shall be allowed.
- e) Bidder shall not be allowed to carry mobile/camera/ laptop in the tender room. The same shall have to be deposited at security in advance and taken back after tender opening.
- f) Details of offers shall be read out to bidders and in no case the offers shall be handed over to any of the bidders for noting down.
- g) Please ensure tender submission, minimum 1 hour before scheduled tender opening time. Late tenders shall not be accepted.

11. **Reverse Auction:**

"BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'online sealed bid' in the Reverse Auction. Non-submission of „online sealed bid“ by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue."

Information and General Terms and Conditions governing RA shall be as per annexure-I.

12. **Delivery Schedule :-**

**FOR LOT-1 and Mandatory Spares** - Delivery shall be within four (04) months from basic Drawing/Documents approval. This is subject to submission of basic drawing/documents by vendor within 3 weeks of PO/LOI and vendor to re-submit documents within 7 days taking care of all comments. In case there are delays of submission of documents beyond 3 weeks of order or 7 days of comments, that much days of delay would be reduced from delivery period.

Lot-1 quantity shall be released during kick-off meeting which will be held within 10 days of date of LOI/PO.

**Subsequent Lots:-** A time lead of 3 months will be given from the date of clearance of quantity for completion of supplies.

**E&C:** Within 05 months from the date of clearance/availability of working front at site as confirmed by BHEL.

13. **Pre-Qualifying Requirement:-**

14. Bidder to note that CIF is not available for this package.
15. All corrigenda, addenda, amendments, time extensions, clarifications, etc to the tender will be hosted on BHEL website ([www.bhel.com](http://www.bhel.com)) & BHEL-PEM website ([www.bhelpem.com](http://www.bhelpem.com)) only. Bidders should regularly visit websites to keep themselves updated.
16. Bidder to note that this is a conditional enquiry for those who are not registered with BHEL PEM and/or are not approved by Customer for the subject project/ package, and the price bid (Part-II) opening/RA shall be subject to following criterion:
  - a) Approval of bidder by BHEL
    - i. 17. Indian Bidders to quote freight charges in percentage of their Total ex-works price.
18. The offers of the bidders who are on the banned list as also the offers of the bidders, who engage the services of the banned firms, shall be rejected. The list of banned firms is available on BHEL website [www. bhel.com](http://www.bhel.com).
19. Foreign bidders quoting along with their Authorised Indian associates to comply BHEL guidelines which is available on <https://www.bhelpem.com/Tenders.aspx>.
20. Construction Power shall be provided at one point on free of cost basis. For all other purposes, i.e. office, quarters etc the electricity charges as per standard rates shall be payable by the subcontractor. Contractor shall make his own arrangements for drawl of power for further distribution. Contractor shall be responsible for the maintenance of his distribution system. Water shall be made available on free of charge basis for construction purpose at single point at the existing power plant.
21. Evaluation will be done on overall L1 (Total cost to BHEL (for both supply and E&C)) basis.
22. "The unit rates of supply & installation ( E & C ) for all equipment and service quoted by the bidder shall be firm for a variation of quantities limited to
  - a.  $\pm 30\%$  of total order value till finalisation of engineering details & BOQ.
  - b. +10% of the total order value in addition to (a) above, till the completion of job."
23. Insurance (Ocean and Inland) is in BHEL's scope.
24. The integrity pact, shall be returned by the bidder, along with their Techno-Commercial Bid, duly filled and signed by the authorized signatory who signs the bid and will form part of the order. Only those vendors who have entered
