9. RISK PURCHASE CLAUSE:

If the supplier fails to deliver the whole or any part of the goods or services within the stipulated delivery period mentioned in the Work Order, BHEL shall be entitled to terminate the contract and to purchase the same or the best and the nearest available substitute from elsewhere at the risk and cost of the seller either the whole or any part of the goods/Services.

In case of deviation or non-acceptance of Risk Purchase clause, offer shall be liable for rejection.

10. SUSPENSION OF BUSINESS DEALINGS:
