- 1. AMC of Digital Notice Board System across BHEL for uninterrupted services and support.
- 2. Technical Specifications: The system comprises the following three components:
  - Server Application: This application is a content management application which user can run on browsers and is installed on the server which is accessed through a secured channel. This application enables the administrator to create, preview and publish the content to the display systems which can deliver messages to targeted specific locations for specific times.
  - **Device:** This is the device (Nano Set up box) where client application is installed and this device connects to LCD/LED TV screens for any type of Display Screen (weather indoor or outdoor using HDMI port).
  - **Client Application**: This is an android device application, which is accessing data from the server based application and getting updated with in fraction of minutes. So if there is any change made on server side, it refreshes the content on client side display board for online solution.

### 1.0 SUBMISSION OF OFFER

- 1.1 Your offer should be complete in all respects.
- 1.2 Price quoted should be firm and net.

#### 2.0 PRICE

- 2.1 All prices quoted be all inclusive, but except GST, if applicable, which should be indicated separately in the column provided in the Price Performa enclosed as Annexure-IV.
- 2.2 Any miscellaneous/ extra charges to be indicated in the column provided in Price Performa enclosed as Annexure-IV.
- 2.3 If in the price structure quoted for the items, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
- 2.4 If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- 2.5 If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to SI. No. 2.3 and 2.4 above.

#### 5.0 **PENALTY DELAY**

- 5.1 Downtime of the Digital Notice Board System, exceeding 24 hours from the time of raising complaint through email/SMS/whatsapp, if and when attributable to the vendor shall be liable to attracting penalty @ 0.5% of the contract value per day.
- 5.2 On account of unsatisfactory performance, unprofessional behavior or any other non-compliance to contract terms & conditions, the service contract is liable to be suspended with immediate effect and BHEL shall start proceedings for termination of the contract as per clause no. 15.0 of General Terms and Conditions (Annexure III) of the tender enquiry.

### **6.RISK PURCHASE**

6.1 If the bidder fails to deliver services or any installment thereof within the period fixed for such delivery and failing to adhere to the contract specifications or at any time repudiates or refuses or is unable to supply services covered by the Order either in whole or in part or commits any breach of order not herein specifically provided for or in the event, BHEL shall be entitled to cancel the order either in whole or portion thereof without compensation to bidder and if BHEL so desires, may procure upon such terms and in such manner as deemed appropriate, at the risk and cost of the bidder and the bidder shall be liable to BHEL for any excess costs provided that the bidder shall continue the performance of the order to the extent not cancelled under the provisions of this clause. Bidder shall on no account be entitled to any gain on such repurchases.

#### 1.0 TAXES

- 1.1 It is mandatory to comply with all taxes applicable for the required services. Your price should be all inclusive, **except GST**. The amount towards GST should be indicated separately in the specified place in Price Performa enclosed as **Annexure-IV**.
- 1.2 To enable BHEL to avail GST Input tax credit, contractor shall submit GST complaint Tax invoice containing all the particulars as stipulated under Invoice Rules of GST Law. Such invoice shall be submitted within prescribed time limit in the name of BHEL Corporate Office, BHEL House, Siri Fort, New Delhi.
- **1.3** Payment shall be made to contractor only after submission of GST complaint tax invoice as mentioned above and other relevant documents.
- 1.4 Payment to the Contractor will be subjected to the TDS as per rules in force from time to time. The Tax deduction at Source (TDS) shall be done as per the provisions of the Income Tax act and GST, as amended from time to time and a certificate to this effect shall be provided to the contractor by BHEL.
- 1.5 GSTIN of BHEL will be provided to the contractor with the LOI.
- 1.6 All documents required for issue of E-way bill shall be provided by the bidder.

### 2.0 PRICE ESCALATION CLAUSE

**2.1** All the prices quoted by the bidders shall be in Indian Rupees and shall be final and binding and not subject to any price escalation.

#### 3.0 VALIDITY OF OFFER

3.1 Your offer should be valid for at least 60 days from the date of opening of the Bid.

### 4.0 TERMS OF PAYMENT

- **4.1** Payment shall be released within thirty days from the date of receipt of bills after submission of requisite proofs of successful completion of the work as per work order.
- 4.2 While making the payment, statutory deductions as applicable, shall be made by BHEL.
- **4.3** BHEL reserves the right to make payment through E-mode. Successful bidder shall be required to furnish the EFT Details upon selection on its letter head as per Annexure IX.
- **4.4** Payment shall be made on quarterly basis upon raising of bills by the vendor.

### 5.0 FORCE MAJEURE

- 5.1 "Force Majeure" shall mean any event beyond the reasonable control of the Purchaser or of the Seller/Contractor including but not limited to fire, flood, earthquake or other acts of God, war, riots, civil war and restraints of Governing States, as the case may be, and which is unavoidable notwithstanding the reasonable care of the party affected. The following events are explicitly excluded from Force Majeure and are solely the responsibilities of the non-performing party: a) any strike, work-to-rule action, go-slow or similar labour difficulty (b) late delivery of equipment or material (unless caused by Force Majeure event) and (c) economic hardship.
- **5.2** If either party is prevented, hindered or delayed from or in performing any of its obligations under he Contract by an event of Force Majeure, then it shall notify the other in writing of the occurrence of such event and the circumstances thereof within 02 (two) days after the occurrence of such event.
- 5.3 The party who has given such notice shall be excused from the performance or punctual perforance of its obligations under the Contract for so long as the relevant event of Force Majeure continues and to the extent that such party's performance is prevented, hindered or delayed. The Time for Completion shall be extended by a period of time equal to period of delay caused due to such Force Majeure event.
- 5.4 Delay or non-performance by either party hereto caused by the occurrence of any event of Force Majeure shall not (a) Constitute a default or breach of the Contract. (b) Give rise to any claim for damages or additional cost or expense occasioned thereby, if and to the extent that such delay or non-performance is caused by the occurrence of an event of Force Majeure.
- 5.5 A bidder shall not be liable for any failure of or delay in the performance of this contract for the period that such failure or delay is due to causes beyond its reasonable control, including but not limited to acts of God, war, strikes or labor disputes, embargoes, government orders or any other force majeure event.

## 6.0 BHEL's FRAUD PREVENTION POLICY

6.1 The Bidder along with its associate/ collaborators/ sub-contractors/ sub-vendors/ consultants/ service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website <a href="http://www.bhel.com">http://www.bhel.com</a> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.

## 7.0 ARBITRATION

- **7.2** Any dispute in respect of which a notice to commence arbitration has been given, in accordance with Sub-Clause 14.1, shall be finally settled by Arbitration.
- **7.3** Any dispute shall be referred to the sole arbitration of Head of Corporate Communication of BHEL or his nominee, within 45 days of the receipt of the notice invoking arbitration.
- 7.4 Subject as aforesaid, the Arbitration proceedings shall be conducted;
- **7.4.1** In accordance with the rules of procedure of the Indian Arbitration and Conciliation Act 1996.
- 7.4.2 The place of Arbitration shall be the place from which the contract is issued or such other place as the Arbitrator at his discretion may determine.
- 7.4.3 The language of the Arbitration proceedings shall be English.
- 7.4.4 The law governing the arbitration proceeding shall be the Indian law and
- **7.4.5** The cost of arbitration shall be borne equally by the parties.

The award of the Arbitrator shall be final and binding upon the parties to the dispute and shall be enforceable in any court of competent jurisdiction as decree of the court.

Notwithstanding any reference to the arbitration herein, the parties shall continue to perform their respective obligations under the Contract not affected by the issues governing arbitration unless they otherwise agree.

#### 8.0 EFFECT AND JURISDICTION OF CONTRACT

**8.1** The law applicable to this contract shall be the laws in force in India. The courts in Delhi, India, shall have exclusive jurisdiction in all matters arising under and on account of this contract.

### 9.0 ACCEPTANCE OF TERMS AND CONDITIONS
