Common Note for all Items:

Vendor should give point-wise reply to the following points:

1. The master, joining and intermediate links shall be welded by any one of the following welding methods as per is-2760/1980. Vendor/ bidder shall specify the welding process to be used, along with the offer.
 - A) Electric Resistance Butt Welding;
 - B) Electric Flash Butt Welding;
 - C) Atomic Hydrogen Welding;
 - D) Gas Shielded Arc Welding (using argon and/or carbon dioxide as shielded gas).
2. Pre-dispatch inspection shall be done by BHEL representative at short link chain manufacturer works for proof load (200% of SWL). Proof load testing shall be done for all the slings during inspection. For the above testing bidder(s)/ vendor(s) has to make all necessary arrangements.
3. For all items test certificates by competent person as per factories act shall be submitted along with supply.

4. Breaking load test of one number sample of the following items should be offered during the pre-dispatch inspection by BHEL representative at the short link chain manufacturer works.

The breaking load shall be noted down

- i) 1 no of main ring used in each item of chain sling.
- ii) 1 no of intermediate link used in each item of chain sling.
- iii) 1 no of joining link used in each item of chain sling.
- iv) 1 no of eye hook used in each item of chain sling.
- v) 1 metre length of short link chain used in each item of Chain sling.

5. The total ultimate elongation shall not be less than 20%, as mentioned in is/iso 3076 /2012.

The actual test values of total ultimate elongation shall be provided in manufacturer test certificate.

6. The identification number, safe working load and the chain sling length shall be clearly punched on the main ring of all chain slings.

In addition, the information such as safe working load, identification number, grade, manufacturer name, year of manufacturer, size of chain, reach of the sling etc., shall be marked on a metal tag or label permanently attached to the master link or a link immediately adjacent to it.

7. The chain slings shall be guaranteed for a minimum period of twelve months from the date of acceptance at BHEL, Thirumayam. Suitable guarantee certificates to be provided along with supply.
