SCOPE OF WORK

A	1	Existing Roofing has to be removed and old sheets to be stacked at store/yard designated by PMG/Civil.
	2	Existing damaged/worn out steel structure members has to be removed/dismantled and replaced by new member.
	3	Existing/New steel structure members has to be cleaned and painted before sheet installation.
	4	Other misc. works as per site / work requirement at the time of execution.
	5	All T&P expect welding electrodes has to be arranged by the contractor.
	6	<u>FREE ISSUED MATERIAL:</u> (a) Only Structural Steel and Welding Electrodes for item No. 1 of BOQ shall be issued free of cost at BHEL store, rest of the material to be arranged by the contractor. (b) Only Sheets for item No. 10 of BOQ shall be issued free of cost at BHEL store, rest of the material to be arranged by the contractor.
B		Following are to be complied with by the contractor during contract execution.
	1	All safety measure has to be taken by the contractor during execution of work and Contractor has to ensure site supervisor at site during execution of work.
	2	All safety equipment's like Safety harness, fall arrester, life line, safety shoe, safety helmet etc are to be provided by the contractor.
	3	Contractor has to ensure that every worker, working at height should be equipped by proper PPE during execution of work.
	4	Work will be done during shutdown period & after issue of work permit through PMG/Civil dept.

E.g. Say 2018-19-NIL, 2019-20-X and 2020-21-Y lacs then Average annual turnover shall be= (NIL+X+Y)/3.	Bidder to take note and confirm	
2.2	Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following: a) Three similar completed works costing not less than the amount equal to Rs. 30.24 Lacs each. OR b) Two similar completed works costing not less than the amount equal to Rs.37.80 Lacs each OR c) One similar completed works costing not less than the amount equal to Rs. 60.48 Lacs.	Bidder to submit required work order copies of the work, along with performance certificate from the customer to whom services were provided. The work order copies should clearly indicate the customer detail, scope of work (similar in nature as mentioned above in clause-1) and total value of work.
