INSTRUCTIONS TO THE TENDERER

EMD as specified above **must be paid** & Tender without EMD will be summarily rejected and the Technical bid & price bid shall not be considered.

(Note: There is no provision of EMD waiver for MSE suppliers and EMD amount as shown above must be paid.)

▪ **Mode of Payment of EMD:**

- (i) Electronic Fund Transfer (EFT) credited in BHEL account (before tender opening).
or
- (ii) Banker's cheque/ Pay Order/ Demand draft, in favour of BHEL (along with offer).
or
- (iii) Fixed Deposit Receipt (FDR) issued by Scheduled banks/Public Financial Institutions as defined in the companies Act. (FDR should be in the name of the contractor and Pledged in the name of Account officer, CFFP, BHEL, Haridwar)

In case total EMD amount is more than 20 Lakh, the amount in excess of 20 lakh is accepted in the form of Bank Guarantee from scheduled bank. The Bank Guarantee in such cases shall be valid for at least six months.
