**1.0 TECHNICAL PQC:**

1.	The bidder should be an OEM of cable Trays and Accessories.	Necessary supporting document establishing in-house manufacturing facilities shall be submitted.
2.	Bidder should have manufactured and supplied Minimum 150 Nos. of 150 mm (W) Perforated FRP Cable Trays in one or more than one order within last 7 years from the date of technical bid opening of this tender.	Copies of Purchase Orders, Proof of supply (viz. MDCC / Invoice / LR / Completion Certificate / Performance Certificate) of respective POs shall be submitted.

**2.0 FINANCIAL PQC**

<b>1.0</b>	<b>Financial Criteria:</b>
<b>A.</b>	Average annual financial turnover of bidder, during the last three financial years, i.e. FY 2019-20, 2020-21, and 2021-22 should not be less than <b>INR 9 Lakhs</b> (or) equivalent in foreign currency. Audited financial statement (Audited Balance sheet & Profit & Loss Account) have to be submitted for all the three years as indicated above. If financial statements are not required to be audited statutorily, then instead of audited financial statements, financial statements are required to be certified by chartered accountant.
<b>B.</b>	Incase audited Financial statements have not been submitted for any of three years as indicated against A above, then the applicable audited statements submitted by bidders against the requisite three years, will be averaged for three years i.e. total divided by three.
<b>C.</b>	Other income shall not be considered for arriving at annual financial turnover/sales.
<b>D.</b>	Bidder has to submit copies of Certificate of Incorporation from the Registrar of Companies/ Partnership Deed/ Proprietorship documents etc., GSTIN registration, PAN card etc. as applicable.

**3.0 GENERAL REQUIREMENTS:**

- A. Bidder shall submit requisite documents, to comply with aforesaid criteria, properly indexed, along with offer.
- B. After satisfactory fulfillment of all the above criteria/ requirement, offer shall be considered for further evaluation as per NIT and all other terms of the tender.
- C. Bidder(s) already registered with BHEL other units or BHEL-PE&SD for subject package, also need to submit credentials for criteria indicated in sl. No. '1.0' '2.0' above. Also, they must submit the relevant documents as the proof of their registration with BHEL – other units for subject package.
- D. Consideration of offer will be subject to customer's approval of bidder.
- E. Bidders should have technological capability for communication/ transmit through electronic media/ reverse auction process.
