1.0	FINANCIAL CRITERIA:
A.	Average Turnover: Average annual financial turnover of bidder, during the last three financial years, i.e. FY 2019-20, 2020-21, and 2021-22 should not be less than INR 6 Lakhs (or) equivalent in foreign currency. Audited financial statement (Audited Balance sheet & Profit & Loss Account) have to be submitted for all the three years as indicated above. If financial statements are not required to be audited statutorily, then instead of audited financial statements, financial statements are required to be certified by chartered accountant. Other income shall not be considered for arriving at annual financial turnover/sales. If audited financial statement is not available for FY 2020-21 then corresponding last three years turnover shall be considered.
B.	Bidder has to submit copies of Certificate of Incorporation from the Registrar of Companies/ Partnership Deed/ Proprietorship documents etc., GSTIN registration, PAN card, etc. as applicable.
2.0	TECHNICAL CRITERIA: A) Technical Qualification Criteria: Bidder to meet following requirement as mentioned below: Bidder should have experience in supplying spares for compressed air system of a power plant in the last 10 years, from the initial bid submission due date. To assess the above qualification, bidder to furnish the supporting documents such as Copy of Purchase Order / LOI / Invoice / LR copy / IRN.
3.0	GENERAL REQUIREMENTS:
A.	Bidder shall submit requisite documents, to comply with aforesaid criteria, properly indexed, along with offer.
B.	After satisfactory fulfillment of all the above criteria/ requirement, offer shall be considered for further evaluation as per NIT and all other terms of the tender.
C.	Bidder(s) already registered with BHEL other units or BHEL-PE&SD for subject package, also need to submit credentials for criteria indicated in sl. No. '1.0' '2.0' above. Also, they must submit the relevant documents as the proof of their registration with BHEL – other units for subject package.
