The TECHNO-COMMERCIAL offer shall be put in a sealed cover and the cover should have the corresponding Techno commercial bid, subject of tender and due Date written on it. If the offer is found in opened condition, the same offer will be liable for rejection. The techno-commercial offer will be opened on the due date. The tenders meeting our techno-commercial requirements will be considered for online initial sealed bid auction at a later date for which eligible vendors will be intimated in due course. BHEL will decide on the starting bid in the REVERCE AUCTION. General Terms and Conditions of Reverse Auction are furnished in the Page No.10 to Page No.16. The terms and conditions specified herein are to be strictly adhered to for all the supplies of Ceralin MS Casings and its allied items under Annual Rate Contract.

- 1. Validity: The rates finalised for the annual rate contract shall be valid for ONE YEAR with effect from release of ARC for supply. The rate contract shall have provision for further extension on same terms & conditions.
- 2.The rates quoted shall be on F.O.R. BHEL-EPD Stores basis without unloading. The rates shall be exclusive of unloading charges but inclusive of freight and insurance. Duties and taxes applicable on date shall be explicitly mentioned. The taxes and duties will be paid extra as applicable on the date of supply. MS casings: Casings shall be supplied in fabricated condition & painted as per our drawings. Fabrication of Casings & rings as per our quality Plan & procedure. Unloading will be BHELcs scope. Delivery requirement indicated in purchase orders shall be adhered unless and otherwise changes are communicated to them by BHEL.

3. VENDOR CAPABILITY & PROCESS REQUIREMENT: The Fabricator shall have adequate facility for a ROLLING, BENDING, MACHINING up to 1000 mm dia., DRILLING up to 40 mm, WELDING (CO2 /ARC) AND GRINDING. The testing facility for Die penetration test and layout checking table i.e Calibrated surface plates of suitable size, Calibrated height gauges of suitable ranges, Calibrated feeler gauges suitable range, Availability of spirit level shall be available in addition to measuring instruments duly calibrated. The Vendor shall have personnel / process qualification where applicable and shall maintain valid record of the same. The Vendor shall have enough trained crew to ensure smooth flow of work in addition to requisite handling facilities.

Periodic calibration of measuring instruments shall be done and necessary calibration certificates shall be shown to QC personnel on demand Only specified electrodes should be used for the fabrication and the vendor shall demonstrate documentary proof for having used the same during process audit.

- 4. Capacity: Vendors minimum capacity to supply 7MT of fabricated casings per month in all category implies vendors ability to supply such quantities of items meeting the quality requirements and delivery schedules. Vendors shall intimate only such capacity that can be allocated exclusively to BHEL and not their total capacity. Those who are not meeting this requirement, their offers are likely to be rejected. To assess the vendor capacity and capability BHEL-EPD reserves the right to visit vendor works before qualifying the %echno Commercial Bid submitted by the vendors.
- <u>5 .Lead time</u>: Offers shall indicate minimum and maximum lead-time required to execute the orders for the capacity indicated. Quantities can be supplied progressively and for such supplies, minimum time required to start supplies and maximum time required to complete the order may be indicated.
- **6.** Quantities of materials ordered from time to time shall be dependent on actual requirement. Delivery dates indicated in the purchase orders shall be adhered to.
- **7**. Each of our purchase order specifies the drawing number and revision number clearly.
- **8**. The orders will be placed against rate contract in phases depending on Vendorcs position in comparative statement of original offers subject to acceptance of counter offered rates, vendor performance ratings/quality and delivery performance of running supplies, vendor capacity and BHEL requirement during the period of contract. The vendors with consistent good performance will be preferred over poor performing vendors and encouraged with more order share.
- 9.INSPECTION AND ACCEPTANCE: The routine inspection of material shall be done by Quality personnel of BHEL-EPD. BHEL reserve the right to inspect the material at vendors works. Good performing vendors are eligible for inspection waival on case to case basis.

10.REJECTIONS:

- i. The items where defects attributed to vendors manufacturing process are noticed at the time of subsequent processing like assembly will be treated as valid rejections. The same shall be either replaced free of cost or payment towards it will have to adjusted from vendors pending bills.
- ii. The rejected lots should be lifted by vendor on his own cost within 15 days notice, Failing which material shall be dispatched back on freight to pay basis through BHEL approved transporter However minor rejections should be lifted once in a year failing which BHEL. EPD will have no liability for such material.

11. Price Comparison: Prices shall be considered on LANDED COST BASIS (COST TO BHEL). Landed cost shall be worked out on price quoted including freight, excise duty, sales tax after taking out CENVAT and VAT Benefit, as applicable. The comparative statement shall be worked out on landed cost basis for EACH ITEM. The comparative statement of the prices prepared on the reference date shall remain firm throughout the execution period. Any change in duty & tax structure during execution of the contract will not be considered for re-ranking of vendors.

A)The lowest price received against BHEL tender need not be commercially lowest price (L1) and BHEL reserves the right to NEGOTIATE the same.

B)BHEL reserves the right/option to REFLOAT the tender if L1 price is not the lowest acceptable price to BHEL.

12.Ranking Price & Load Share: For ranking the vendors as L-1, L-2, L-3õ ..., the basis will be lowest tender value arrived at with quoted prices and tender quantity for each item is the basis. As far as possible, the loading on the annual basis shall be made among 5 successful vendors in the ratio of 30:25:20:15& 10, subject to acceptance of negotiated L1 rates.

However, if sufficient vendors are not accepting L1 rates, order will be distributed in following ratios.

60:40 among two successful vendors

50:30:20 among three successful vendors

40:30:20:10 among four successful vendors.

30:25:20:15:10 among five successful vendors.

If no vendor is accepting L-1 rates total 100% order will be given to L-1 Vendor only.

In case of more than one vendor having same ranking, the load share corresponding to the ranking and the next ones will be clubbed together and will be equally distributed among such vendors.

In case, any eligible vendor does not accept the counter offer, opportunity will be given to the next ranking vendor. If L1 vendor capacity less than our requirement, then balance qty.will be distributed equally among other eligible vendors.

- **13.** <u>Payment Terms</u>: 45 days credit after receipt of material at BHEL stores along with relevant documents through NEFT.
- **14.** <u>Risk Purchase Clause</u>: BHEL at its option will be entitled to terminate the contract and purchase elsewhere at the risk and cost of the seller either the whole of the goods or any part which the seller fails to deliver within the stipulated time. The seller shall be liable for any loss, which BHEL may sustain by such risk purchases. The loss may be recovered from the vendors outstanding bills with the concerned unit or any sister unit.
- **15.** In case of unsatisfactory performance of quality / delivery BHEL will have right to discontinue the contract in part or full.
- **16.** Appropriate care has to be taken while shipping the MS casings to avoid transit damages / losses. In the event of any damages the supplier is liable to replace the goods. Vendor also to be ensured that the person who driving the truck/lorry should have valid licence and same is to be produced at the time of entering into Bhel-Gate

.

- **17. Delivery basis.** Vendor must agree to delivery term of FOR-BHEL-Stores and Payment term as per clause 13 and no deviation shall be allowed.
- **18.** Acknowledgement of BHEL Stores shall be only legal document towards receipt of material.
- **19.** The vendors will have to follow all the legal and statutory requirements and BHEL norms. BHEL will not be responsible in any way if the vendor is fined or penalized due to non-fulfillment of these requirements by any government agency like Sales Tax, Excise etc.
- **20. Arbitration:** Settlement of dispute, if any arises, at anytime between the BHEL and the vendors upon or in relation to or in connection with the vendor, the same shall be referred to the sole arbitration of the Head of BHEL unit or to person appointed by him. The award of the arbitrator shall be final and binding on both BHEL and the vendor
- **21.** LD Clause: In case of delayed delivery, LD @ 0.5% per week up to a maximum of 5% will be levied on the defaulting quantity for the delayed period as per the corresponding PO.
- **22.** Legal Jurisdiction: In case of any legal proceedings, area of jurisdiction will be Bangalore in case of EPD.
- **23.** Vendor registration forms accompany with the latest IT returns, Balance sheet/Annual report, Sales tax validity certificate is compulsory to be furnished along with your offer. The units registered under SSI should also furnish the validity certificate for the same. Excise authority certificate should also be furnished.
- **24.** Earnest Money Deposit: Along with Techno Commercial Bid an EMD of Rs.1,00000(Rupees one lakh only) by way of DD to be submitted. DD drawn in favour of %BHEL-EPD,BANGALORE +. For unsuccessful bidders an EMD will be returned within 30 days from the date of completion the tender process.EMD will not carry any interest. For successful Vendors it will be converted as security deposit and will be returned after completion of the contract period without any interest. Tenders without EMD will not be considered.
 - **25.** The tender not meeting the above conditions may not be entertained.

- 2- Price of 6 mm MS plate and MS melting scrap (HMS-II) at the preceding month of dispatch as published in %PCINDIANSTEEL.NIC.IN (with CHENNAI Rates) has been chosen as the reference. PV rate for the month will be arrived at with respect to average price prevailing during the preceding month and the same will be communicated to all the vendors. The vendor has to prepare their PV claim with reference to the PV rate applicable for the schedule delivery date or actual delivery date whichever is least.

- 3- Vendors have to submit a consolidated bill for additional P.V. amount once in a month for all the supplies made within the month, with complete calculation as per above formula

- 5- If 6mm M.S. Plate rates at any point of time of the contract period will be less than the 6mm M.S. Plate rates prevailing at the time of finalizing of Rate Contract, vendors have to give a credit note for deducting the calculated amount as per above formula from their existing bills, otherwise BHEL have every right to deduct the calculated amount from the existing bills of vendors.

- 1. **LOG IN NAME & PASSWORD:** Each Bidder is assigned a Unique User Name & Password by Service Provider The Bidders are requested to change the Password and edit the information in the Registration Page after the receipt of initial Password from Service Provider All bids made from the Login ID given to the bidder will be deemed to have been made by the bidder.
- 2. **BIDS PLACED BY BIDDER:** The bid of the bidder will be taken to be an offer to sell. Bids once made by the bidder cannot be cancelled. The bidder is bound to sell the material as mentioned above at the price that they bid. Should any bidder back out and not make the supplies as per the rates quoted, BHEL and / or Service Provider shall take action as appropriate.
- 3. **Auction Start price & Decremental Value:** The start price & Decremental value applicable in the on line reverse auction will be decided by BHEL after evaluating the bids received from the vendors in the on line initial sealed bid auction and will be available to the vendors on the bidding screen of the online reverse auction.
