ANNEXURE – 1 TO TCN-01**PRE QUALIFYING CRITERIA (TECHNICAL)**

- A) Supplier should have designing/manufacturing capability and having testing facility (in house or outsourced).
- B) Condensate Polishing Plant with external regeneration system (running either in hydrogen cycle or combination of hydrogen and ammonia cycle), comprising of at least two (2) deep mixed bed type service vessels operating in parallel and in conjunction with the main TG unit. Each of these vessels shall have a minimum capacity of 325 m³/hr. The vendor shall be qualified for plants having similar external regeneration system with associated mechanical, electrical & control systems, incorporating the same resin separation and regeneration process as adopted in the plants by virtue of which he is qualified as mentioned above.
- C) Condensate polishing unit should have been successfully in use for at least one year in power plant or other industries e.g. refinery/steel/process/commercial etc. For this the supplier has to submit either of following supporting documents meeting below mentioned conditions.
- i) Copy of minimum one (1) performance certificate in English from end user along with copy of related Purchase Order specifying that the product is running successfully for one (1) year from date of commissioning.
- OR
- ii) Minimum one second/repeat purchase order (placed with a minimum gap of one (1) year after commissioning of first order) from same purchaser meeting the minimum pre-qualifying requirement.
- OR
- iii) Minimum three purchase orders (placed with minimum gap of one (1) year from previous purchase order) from same purchaser meeting the minimum pre-qualifying requirement
- D) Supplier to submit the following major documents:
- i) Vendor shall submit design documents to substantiate technical parameters specified in PQR, if the same is not mentioned in performance certificate/purchase order.
 - ii) Minimum two (2) nos. Purchase orders shall be submitted which should not be more than ten (10) years old as on date of application for registration/bid submission, for establishing continuity in business.
 - iii) Vendor may also qualify based on the credential of principal meeting package specific pre- qualifying requirements having technical valid collaboration/licensing agreement.
