Execution Time Schedule for such additional scope or deleted scope will be decided by BHEL and that will be accepted by the Vendor without any prejudices.
56.6	In case of "part withdrawal of work" or "termination of contract" due to any reason or "scope reduction due to downward quantity variation beyond variation limits mentioned in the Quantity Variation clause of the contract", no bonus (Incentive for performance) shall be applicable.
56.7	Contract value for considering bonus (Performance Incentive) shall be same as defined in LD clause.
56.8	Trial run & COD as specified vide Clause No. 28.5.6 of TCC shall be considered for application of bonus.
56.9	Actual completion date should be the date mentioned in the Work Completion Certificate in line with Measurement Book.
56.10	Vendors / Bidders not accepting the schedule of Trial run & COD as specified vide Clause No. 28.5.6 of TCC of this tender shall be rejected by BHEL.
