Amendment to GCC

1. Clause no. 1.10.1 & 1.10.2 of GCC shall be read as below:

Cl. No. 1.10.1

- i. Upon acceptance of tender, the successful Tenderer should deposit the 5% of the contract value as Security Deposit towards fulfilment of any obligations in terms of the provisions of the contract. Bidder agrees to submit this Security Deposit required for execution of the contract as per manner specified in the contract within the time period mentioned in clause 1.10.2.

Cl. No. 1.10.2

- i. Atleast 50% of Security Deposit should be furnished against a contract before start of the work by the contractor.

Case 1: In case Security Deposit is submitted after start of work as per manner specified in the contract, interest (SBI Base rate + 6%) for the delayed period on the (50% amount of SD due for submission minus the cash portion of EMD retained as part of SD, if any), shall also be submitted by the bidder. Balance Security deposit, as applicable shall be recovered at the rate of 10% of the gross amount progressively from each of the running bills of the contractor till the total amount of the required security deposit is collected. In this case, cash portion of EMD of the successful tenderer shall be converted and adjusted towards the required amount of Security Deposit.

Case 2: If requested by the contractor, cash recovery of atleast 50% of the specified Security Deposit, including the cash portion of retained EMD can be made from bills submitted by contractor. For such delay in submission of the required Security Deposit, interest shall be levied for the delayed period of submission at (SBI Base rate + 6%) on such amount deducted from bills to achieve atleast 50% of security Deposit amount required to be furnished before start of the work. Balance Security deposit shall be recovered at the rate of 10% of the gross amount progressively from 1st Running Bill of the contractor till the total amount of the required security deposit is collected.

- ii. In case of small value contracts not exceeding Rs. 20 lakhs, work can be started before the required Security Deposit is collected.
- iii. Payment against a contract can be released only after collection/ recovery of initial 50% Security Deposit.
