- 1.7 Next damage engine of fork lifter shall be issued to the party by BHEL only after handing over the previous repaired engine to BHEL, by the party.

 - a. Three similar completed works contracts during last 7 years ending 31th Aug -2019 each costing not less than the amount equal to Rs.0.44 Lacs.
