- In case vendor is able to meet criteria at Sl. No. 2 only and not Sl. No. 1 above, vendor can tie-up with any lighting manufacturer (herein termed associate) who is meeting all criteria mentioned in S. No. 1 & submit the credentials of associate. Vendor to submit MOU on non-judicial stamp paper of Rs. 100 /- with associate at bidding stage.
- Bidder to note that MOU on non-judicial stamp paper once offered to BHEL cannot be changed till the execution of the project.

General Points of PQR:
