5. Date of receipt at BHEL, Jagdishpur works shall be treated as date of delivery.
6. **Delivery** – Within **three weeks** from issue of PO/LOI.
7. **Delivery Terms**:- F.O.R -CSU Jagdishpur
8. **Guarantee**:- The equipments shall be Guaranteed for 12 months from date of acceptance of equipment.
9. **Terms of Payment**:
  - i) 80% of payment with 100% of taxes and duties shall be made on receipt of material and balance 20% of payment on acceptance of the material.
  - ii) All bank charges shall be to vendor's account.
  - iii) Supplier should submit the original tax invoice.
  - iv) Supplier should mention their TIN no. on the bill.
10. **Penalty for Delay**
  - (i) The delivery of equipment shall be made within the time prescribed. Failure to dispatch the equipment in time as per the delivery specified above would make the vendor liable to an un-conditional penalty at the rate of one half percent (1/2%) of the order value for delay of each week (or part thereof) Subjected to a maximum of ten percent (10%) of the order value.
