2.0 QUALIFICATION REQUIREMENT FOR 'A'

2.1 For Cranes up to 18MT capacity.

The agencies should have executed repair, maintenance, dismantling, loading, unloading, assembly and commissioning of 8T Cranes or above in the last 7 years.

Average annual financial turn over during the last three years ending 31st March of the previous Financial year (31-03-2009) should be at least 15/- (Fifteen) Lakhs

2.2 . For Cranes up to 75 MT

The agencies should have executed repair, maintenance, dismantling, loading, unloading, assembly and commissioning of 18MT crawler Cranes or above in the last 7 years.

Average annual financial turn over during the last three years ending 31st March of the previous Financial year (31-03-2009) should be at least 30/- (Thirty) lakhs

2.3 For Cranes up to 150MT

The agencies should have executed repair, maintenance, dismantling, loading, unloading, assembly and commissioning of 70MT Hydraulic crawler Cranes or above in the last 7 years.

Average annual financial turn over during the last three years ending 31st March of the previous Financial year (31-03-2009) should be at least 12 (Twelve) Lakhs

- 2.5. The agencies should have executed repair, maintenance, Dismantling, loading, unloading, assembly and commissioning of 150T Hydraulic crawler Cranes or above and dismantling and assembly of Heavy Lift Assembly (Ringer) of FMC crane in the last 7 years.
