1.0. SCOPE OF WORK

- 1.01. Providing services of Engineer/Technician, for repair, servicing, Preventive maintenance works, loading & unloading of various construction equipments such as Electrical winches, Hydraulic Test Pumps, Tube expanding machines, Passenger cum goods lift (Sky rack), Boiler maintenance moving platform (Sky climber/Skyman), Acid cleaning Pumps, Miscellaneous Pumps, Huck bolting machine, Hydraulic Jacks, Induction heating equipments, Diesel Generators, Pipe bending machine, Pipe chamfering machine, oil centrifuge, Transformer oil filter machine, Air compressors and other service equipments except cranes and welding Generators available at PSSR sites and other places for a period of two years.
- 1.02. Supply of sundry spares
- 1.03 Reconditioning Worn out components.
- 1.04. Fabrication of base frames and packer plates etc for construction equipments

2.0. SERVICE CHARGES:

- 2.01 Service charges shall be quoted as per the rate schedule format enclosed. Rates quoted shall be firm for a period of TWO YEARS from the date of acceptance of the work order.
- 2.02. Service Tax and other applicable taxes if any shall be paid extra on production of relevant documents.
- 2.03. Taxes and duties for spares as applicable for the supply of spares shall be paid by BHEL extra.

3.0 <u>TIME SCHEDULE</u>

The agency shall provide the services to attend the complaints within week's time at sites after the receipt of written confirmation from site, followed by FEX. PSSR HQ

4.0 TERMS OF PAYMENT.

90% payment will be released at BHEL/PSSR/HQRS/CHENNAI on submission of the invoice duly certified by SITE IN CHARGE of the site. Remaining 10% shall be payable after the completion of the contract. EMD will be converted into security deposit and shall be released for payment after successful completion of the contract.

- 4.01. Payment for the sundry spares will be reimbursed as per the price list of the OEM/OCM or Authorized dealers of Original equipment manufacturer/original component manufacturer and handling charges like freight, conveyance and transport charges shall be paid by BHEL as per documental evidence as certified by the Engineer/In charge of respective sites/places.
- 4.02. TAXES & DUTIES FOR SPARES: Taxes and duties for spares as applicable for the supply of spares shall be paid by BHEL extra

5.0. TOOLS AND PLANTS.

- 5.01. The small tools and plants such as spanners, screw jacks etc required for the work shall be arranged by the bidder. All Major tools and plants such as cranes, welding machine and Hydraulic jacks and other special tools & plants which are considered to be not possible to arrange by the bidder required for attending the repairs shall be provided by BHEL free of hire charges.
- 5.02. D shackles, wire ropes and slings may be provided by BHEL at the respective sites/places free of hire charges subject to availability.

6.0. CONSUMABLES.

- 6.01. Necessary consumables like Diesel, petrol, Kerosene, gas, lubricating oils, filters and grease and welding electrode will be provided by BHEL free of cost. Necessary T & Ps required for carrying out greasing shall be provided by BHEL free of hire charges.
- 6.02. Wooden Sleepers if available will be provided free of charges by BHEL at sites. They are to be properly accounted and returned to BHEL STORES after the completion of work.

7.0 SUPPLY OF SPARES:

- 7.01. All the spares costing 1.0 % of the present replacement cost of each Equipment shall be arranged by the Tenderer as sundry spares if the spares are not provided by BHEL. Payment for the sundry spares will be reimbursed as per the price list of the OEM/OCM or Authorized dealers of Original equipment manufacturer/original component manufacturer and handling charges like freight, conveyance and transport charges shall be paid by BHEL as per documental evidence as certified by the Engineer/In charge of respective sites/places.
- 7.02. Spares for the equipments which are obsolete model, the rate contract agency will arrange spares from available sources incase of non availability of spares with OEM. The cost of those items shall be compared with price list of OEM for price justification.
- 7.03. TAXES & DUTIES FOR SPARES: Taxes and duties for spares as applicable for the supply of spares shall be paid by BHEL extra
- 7.04. All Major spares shall be arranged by BHEL.

8.0. RECONDITIONING:

- 8.01. Reconditioning of worn out items on equipments shall be carried out by the rate contract agency at 30% of the original spares cost with guarantee of Six months.
- 8.02. Any repair and servicing to be carried out on engine through OEM and other major components of the equipments through OCM shall be assigned through the rate contract agency to the Original equipment manufacturer or the Authorized dealer. Expenditure involved for repair and servicing shall be paid by the rate contract agency to OEM/OCM Authorized dealer and same will be reimbursed to the rate contract agency on production of valid documents for the expenditure incurred for such works and the service charges to the agencies for the service rendered. Transportation and other charges will be reimbursed by BHEL for this work if not arranged by BHEL.
- 8.03. It is the responsibility of the contractor to take precautions for safe working and avoid any damage to the property/equipments lying nearby, failing which the cost towards the repair/replacement will be recovered from the contractor.
- 8.04 It is the responsibility of the contractor to arrange passes or entry permit as per BHEL/CUSTOMER procedure followed in the plant premises through BHEL Site office.
- 8.05 It is the responsibility of the contractor to follow the safety precautions while carrying out the work.
- 8.06. The contract will be awarded at L-1 rates (Lowest rates arrived) to more than one agency whoever agree to operate at L-1 rates.
- 8.07. Unskilled workers, if required shall be provided by BHEL free of cost.

- 8.08 Service charges per day will be paid for 10 hours per day. Agency shall be available for work minimum 10 hours per day including one hour lunch brake. Generally the work is to be carried out as per the BHEL timings at site. However depending upon the requirements /exigencies the job is to be continued beyond normal working hours. Sometimes round the clock, tenderer should provide required manpower to meet the needs as part of contract and the payment for the extended hours of work will be made proportionately at the accepted service charges per day. at no extra cost. it may please be noted that it is a construction site and such situations are normal.
- 8.09. Service charges shall be payable whenever the services are provided during the holidays. Service charges shall be payable as per the accepted rates for service.
- 8.10. Service charges shall not be payable when there is no work on holidays. However accommodation charges shall be payable if the services are commenced and continued before and after holidays.

9.0 STATUTORY REQUIREMENTS.

All statutory requirements as per labour laws like Insurance, PF etc., have to be arranged by the Tenderer.

Necessary insurance (covering WC Act) for the workmen engaged by the Tenderer has to be taken at his cost and the copy of the same should

be submitted before commencement of the work. A copy of the policy covering the staff to be engaged for a period of two years should be submitted within 10 days after the receipt of the Work Order or Necessary insurance policy for the work men engaged shall be taken at the respective site before staring the work at site
