SPECIAL TERMS AND CONDITIONS

NAME OF THE TENDER: HIRING OF COMMERCIAL VEHICLE FOR OFFICIAL USE AT IVP, GOINDWAL

PRE-QUALIFYING CRITERIA:

• PAN No- PAN card Copy

OTHER TERMS AND CONDITIONS:

- The Bidder must submit a declaration that no case is pending with the police/court against the proprietor/firm/partner or the company(Agency). As well as the bidder has not been suspended / blacklisted by any organization.
- The bidder Must submit a declaration that he has sufficient/required number of qualified drivers for providing required taxi service.
- Charges shall be paid as per quoted price in the price bid format and the extra charges mentioned under the Techno commercial bid.
- The contract shall be initially for a period 02 years and the same can be extended for another **One** year with mutual consent on same rates, terms and conditions.
- If the BHEL is not satisfied with the service of the vehicle, the BHEL, IVP Goindwal is at liberty to terminate the contract at any time by giving one-month Notice.
- Statutory deductions will be applicable like income tax deductions (TDS).
- TDS on GST will be deducted as applicable
- Swift Dezire / Tata Zest/ Toyota Etios (Five Seater Sedan) AC-Diesel is likely to be in normal
 operation in and around Goindwal, Amritsar, Jalandhar, Kapurthala Ludhiana, in addition
 to local travel, the vehicle may also be required to go to cities like Delhi and other cities
 for which the intending bidder must have all valid permits for such out station journeys
 or the bidder shall arrange the permit for the journey with his own cost. No payment shall
 be made by BHEL for procuring such permits.
- The Maruti Omni Ambulance(Petrol) likely to be in normal operation Goindwal, Kapurthala, Jalandhar and Amritsar for emergency requirement (including medical treatment) of employees and their dependents as per the requirement and directions of the transport in charge/Medical superintendent. The Maruti Omni – Ambulance(Petrol) will be deployed on working days. However, the Ambulance may be called on Sundays and holidays, as per requirement.

- The extra charges for Sunday/Holiday will be given as mentioned Fuel and Extra charges under the Techno Commercial bid. The bidder has to make arrangement for necessary modification, fabrication and installation of the equipment's essential for ambulance like stretcher, long seat, oxygen stand etc. Consumable items like – first aid kit, oxygen cylinder etc. shall be provided by BHEL.
- The Commercial vehicles will be deployed on all working days. However, the vehicle may
 be called on Sundays and holidays, as per requirement. The extra charges for
 Sunday/Holiday will be given as mentioned in the <u>Sunday/Holidays</u> under techno
 commercial bid.
- All vehicles shall be having commercial vehicle registration & road permit and necessary passing from RTO.

DRIVER

- 1. The contractor shall provide driver(s), in proper uniform (Grey Color), Photo ID Card, and should be fully conversant with different routes to undertake journey by the shortest route. The contractor has to engage driver for ambulance (for 2 shift operation/20Hrs).
- 2. The driver should always be polite, courteous and able to communicate in Hindi, Punjabi properly. If any person(s)/drivers engaged by the bidder is found to be undisciplined or misbehaved or under influence of any intoxicant, BHEL may ask service provider to replace the same with immediate effect.
- 3. The contractor shall assign the job of driving of hired vehicles only to qualified experienced licensed drivers and also assume full responsibility for the safety and security of the officers/officials as well as essential store items while running the vehicle by ensuring safe driving. BHEL, Goindwal shall have no direct or indirect liability arising out of such negligence, rash and impetuous driving which is an offence under section 29 of IPC and any loss caused to BHEL, Goindwal have to be suitably compensated by the contractor.
- 4. The driver should have sufficient cash to pay any fuel charges/ toll tax / parking charges / entry tax as and when required and also should be in position to pay for any minor repairs necessitated due to sudden breakdown of the vehicle on the road. In no case, money should be borrowed from the occupant of the taxi. Any payment to driver including his food and incidental shall be borne by contractor.
- 5. A statutory compliance certificate in respect of engagement of drivers has to be submitted by the party in each and every month along with the bills.
- 6. In any point of time any breach of the statutory compliance is the sole responsibility of the contractor and the bidder has to indemnify BHEL on account of statutory dues.

- 7. He will abide by all the rules & regulation required for drivers of commercial vehicle. He must be provided a mobile by the contractor.
- 8. In case of any emergency payment of money by BHEL official for purposes mentioned , the same will be recovered from next bill along with 10% overhead charges.
- 9. Running Charges for re-fueling made off-route shall not be borne by BHEL.

DUTY TIMINGS

- a. Swift Dezire / Tata Zest/ Toyota Etios (Five Seater Sedan) AC-Diesel shall be deployed for 10 hours and should be parked inside the BHEL, IVP factory premises after working hours, and on Sundays/Holidays also, at the space provided by BHEL. The driver has to report for duty at 9.00 AM and driver retained or worked more than 10 hours will be provided over time @ Rs.30/- (Rupees Thirty Only) per hour. In case non-providing or delays in reporting more than 15 minutes (as time schedule mentioned) or a part thereof a penalty of Rs.100/- will be charged beyond the stipulated reporting time.
- b. The Maruti Omni -Ambulance will deployed for 20HR operation (Timings as communicated from time to time) and the ambulance should be parked inside the factory premises (including Sundays/holidays) at the space provided for parking.
- c. The Contractor shall ensure the running of Taxi on the stipulated timings given by the BHEL, IVP Goindwal and also in compliance to any further direction given by the officials of the BHEL, IVP Goindwal or officials travelling by the taxi.

LIQUIDATED DAMAGES & PENALTIES:

- ➤ The party has to deploy the required vehicles within 01 month of time from the date of award of work. Delay in providing vehicle will attract liquidated damages @ 0.5 % per week subject to maximum 5% of total value of fixed charges of that particular vehicle for entire duration of the contract.
- The vehicles provided by the contractor shall be maintained in excellent running condition during the period of contract and the vehicle provided should be thoroughly washed and cleaned. The vehicle shall be used for local/outstation journeys by BHEL officials/Guests depending upon the requirement.
- Air-conditioning system (Cooling/heating) should remain in operation as per requirement of travelling officials. No extra charges will be paid for it (As per Applicable)
- ➤ Vehicle must be registered with concerned RTO shall be supplied to BHEL, Goindwal and copies of proof of Registration certificate, road tax paid, insurances, shall be submitted. Any further dues on such vehicles shall be liability of the contractor. At the time of

- deployment of vehicle, the vendor should submit the above copies along with the details of the driver to be deployed along with his valid driving license.
- ➤ Copies of Renewal of insurance, road taxes, pollution certificate of Vehicles has to be submitted to the contracting department within 07 days of time from the date of expiry of the above. Failing to submit the renewal copies of insurance, road taxes of any vehicle, that vehicle will be discontinued form the deployment and an amount of Rs.500/- (Rupees Five Hundred Only) will be imposed as fine per day per vehicle. Alternative arrangement will be made by BHEL on Risk purchase clause and the same shall be recovered from the contractor's bill.
- In case of on-route break down, the vehicle shall be replaced by suitable vehicle immediately. In case the alternate vehicle is not provided, BHEL is free to engage another vehicle to complete the remaining journey at the risk purchase clause and the same shall be recovered from the contractor's bill.
- In case of non-availability /non-providing the vehicle on any day, alternative vehicle of the same type should be provided or it shall be hired by BHEL on Risk purchase clause and the same shall be recovered from the contractor's bill.
- In case the vehicle met an accident during the journey, the contractor will be given 10 days of time for repair and maintenance. Beyond 10 days of time, if the vendor fails to redeploy the vehicle, BHEL is free to engage another vehicle to resume the service at the risk purchase clause and the same shall be recovered from the contractor's bill. This tentative kilometer indicated per vehicle are only indicative and the vehicle would require to run more or less than this figure as per requirement without any limit. The odometer (distance meter) of the vehicle will be jointly signed by the owner or his authorized representatives and a person in charge, BHEL. No vehicle without working odometer shall be acceptable. Proper log book shall be maintained for each travel and has to be got signed by the guest /user travelling in the vehicle.

BILLING AND PAYMENT TERMS

- a. Bills shall be submitted for payment on monthly basis within 30 days after end of month.
- b. Vehicle owner will maintain logbook and will get each journey signed from the concerned official. No cutting /overwriting is allowed in the logbook. If any cutting or overwriting is made in the logbook, the same shall be countersigned form the user. Original Copy of the logbook will be submitted along with monthly bill for verification and determination of the kilometers run. Starting & closing journey will be reckoned

- from the garage notified in the offer. Old logbooks (completed Log Books) has to be deposited to HR/BHEL, Goindwal for record purposes.
- c. Income Tax (TDS) shall be deducted at source from the running bill as per applicable Income Tax Rules and other statutory requirement from time to time.
- d. TDS on GST will be applicable as per the rules
- e. All these documents as applicable taken together shall be deemed to form one Contract and shall be complementary to one another. "Work" means, the work described in the Tender documents in individual work-orders as may be issued from time to time to the Contractor by the Officer-Incharge within the power conferred upon him including all notified or additional items of works and obligations to be carried out as required for the performance of Contract.
 - b) "Contractor" means, the individual Firm or Company whether incorporated or not, undertaking the work and shall include the legal personal representatives of such individuals or the persons composing the firm or Company or the successors of the firm or company and the permitted assigns of such individual or firm or Company.
 - c) "Officer-In charge" means, the Officer deputed by BHEL, IVP Goindwal, to supervise the work or part of the work.
 - d) "Approved" and "Directed" means, the approval or direction of BHEL, IVP Goindwal official, or person deputed by him for the particular purposes.
 - e) "BHARAT HEAVY ELECTRICALS LIMITED" (herein after referred to as BHEL) shall mean the Board of Directors, Chairman, Executive Director, General Manager or other Administrative Officer of the said Company authorized to invite Tenders and enter into Contract for works on behalf of the Company.
 - f) "Contract sum" means, the sum accepted or the sum calculated in accordance with the prices accepted in Tender and / or the Contract rates as payable to the Contractor for the execution of the work during the currency of the Contract.

17) RISK PURCHASE

- a) In the event of any successful Tenderer's failure to fulfil any of the Tender / Contract obligations as per Contract / Agreement BHEL may entrust the job to alternate source and get it completed to meet BHEL requirement and additional expenditure, if any, including consequential cost viz., demurrage etc., will be fully recovered from the Tenderer Contractor who failed to complete the job in line with Contract.
- b) The decision of BHEL with regard to the actual losses / consequential expenditures incurred by BHEL shall be final and binding on the Tenderer / Contractor.

18) LIQUIDATED DAMAGES (LD) / PENALTY:

- a) If the contractor fails to complete the service/work as per terms & conditions of the order within the delivery schedule, a) LD shall be levied @ 0.5 % of the order value per week of delay or part thereof subject to a maximum of 10% of the full order value.
- b) In case of any change to the order value, the LD shall be @ 0.5 % of the revised order value per week of delay or part thereof subject to a maximum of 10% of the revised order value.

19) INDEMNITY:

- a) The Contractor shall have to indemnify BHEL against all claims for injury or damage to any person or property caused by his negligence or negligence of his employees whilst in BHEL premises / sites.
- b) The Contractor shall indemnify the company against all payments by way of compensation or otherwise which the company may be called upon to make under the provisions of the applicable

Acts to any Contract employee as aforesaid, and any cost incurred by the company in connection with any claim preferred by such Contract employee and or against all actions, claims and demands whatsoever in respect thereof or in respect of any loss, injury or damages whatsoever to any third person arising out of or occasioned by the negligent, imperfect or improper performance of this Contract by the Contractor, their employee servants or agents.

- c) The Contractor approved and operating under the Tender, Works Contracts shall further indemnify BHEL against:
 - i) Observance of Labor & Industrial Laws.
 - ii) All claims by way of compensation and all other types of unforeseen claims, which may arise in the course of Contract.
 - iii) Documentary compliance relating to billing.

20) RIGHTS

- a) BHEL may enter into parallel Contract simultaneously with any number of Contractor as may be deemed fit at any time during the period of Contract in the Interest of the work for any or all the stations and for any or all the schedules.
- b) In case of breach of any of the terms and conditions of the Contract, BHEL will entrust the work to any other Contractor at the risk and cost of the Contract and the Contractor shall be liable to pay the extra expenditure, damages, loss suffered on account of the cancellation of the Contract.
- c) All amounts including the losses / damages / penalties / compensations etc., resulting from non-compliance with the terms of Contract, payable by the Contractor to BHEL under the Terms of the Contract will be recovered from the outstanding payments to Contractor either under this Contract or any other Contracts or from Security Deposit or from both. In case this amount is insufficient for such recoveries, the Contractor shall make good the balance amount by actual payment. In addition, BHEL, IVP Goindwal will recover the said amounts through its sister concerns, from the payments due to the Contractor in any of the units of BHEL located in any part of India.
- d) The Contractor is not allowed to pass the responsibilities connected with the Contract to other agencies / Contractors, the Contractors shall not sublet or transfer the Contract or any part thereof, which tantamount to termination of the Contract and thereby attracting the penalty or forfeiture of security deposit.
- e) The Contractor shall have no right to demand at any time during the currency of this Contract any minimum quantity of Work for this Contract.
- 21) PRECAUTIONS AGAINST RISK: The Contractor shall be responsible for providing at his own expense for all precautions to prevent loss or damage from any and all risks and to minimize the amount of any such loss or damage and for the necessary steps to be taken for the said purpose.
- 22) DAMAGE & LOSS TO PRIVATE PROPERTY & INJURY TO CONTRACT EMPLOYEE: The Contractor shall at his own expense reinstate and make good to the satisfaction of BHEL and pay compensation for any injury, loss or damage occurred to any property or rights whatever including property and rights of BHEL (or agents) servants or employee of BHEL, the injury loss or damage arising out of or in any way in connection with the execution or purported execution of the Contract and further the Contractor shall indemnify, the BHEL against all claims enforceable against BHEL (or any agent, servant or employee of BHEL) or which would be so enforceable against BHEL where BHEL is a private person, in respect of any such injury (including injury resulting in death) loss or damage to any person whomsoever or property including all claims which may arise under the Workmen's Compensation Act or otherwise.
- **23) LAWS GOVERNING THE CONTRACT:** The Contract shall be governed by the Indian Laws for time being in force.

24) CANCELLATION OF CONTRACT FOR CORRUPT ACTS: -

a) BHEL, whose decision shall be final and conclusive, shall without prejudice to any other right or remedy which shall have accrued shall accrue thereafter to BHEL cancel the Contract in any of the following cases and the Contractor shall be liable to make payment to BHEL for any loss or damage resulting from any such cancellation to the same extend as provided in the case of cancellation for default.

- b) If the Contractor shall: -
- c) Offer or give or agree to give to any person in BHEL service any gift or consideration of any kind, as an inducement or reward for doing or for bearing to do or for having done or for borne to do any act, in relation to the obtaining or execution of this or any other Contract for BHEL service, OR
- d) Enter in to a Contract with BHEL in connection with which commission has been paid or agreed to be paid by him or with his knowledge, unless the particulars of any such commission and the terms of payment thereof have previously been disclosed in writing to BHEL. OR
- e) Obtain a Contract with BHEL as a result of ring Tendering or by non-bonafide methods of competitive Tendering, without first disclosing the fact in writing to BHEL.

25) CANCELLATION OF CONTRACT FOR INSOLVENCY ASSIGNMENT OF TRANSFER OR SUB-LETTING OF CONTRACT: -

- a) BHEL, without prejudice to any other right or remedy which shall have accrued or shall accrue thereafter to BHEL shall cancel the Contract in any of the following cases:
- b) If the Contractor, being an individual or if a firm any partner thereof shall at any time be adjudged bankrupt or have a receiving order for administration of his estate, made against him or shall take any proceedings for liquidation or composition under any bankruptcy Act or assignment of his effects of composition or arrangement for the benefit of his creditors or purport to do so, or if any application made under any:
- c) Bankruptcy Act for the time being in force for the sequestration of his estate or if a trust deed be granted by him on behalf of his creditors OR
- d) being a Company, shall pass a resolution or the Court shall make an order for the liquidation of its affairs, or a receiver or Manager on-behalf of the debenture holders shall be appointed or circumstances shall arise which entitle the Court or debenture holders to appoint a receiver or Manager, OR
- e) Assigns, Transfers, Sub-lets or attempts to assign, transfer or sub-let any portion of the work without the prior written approval of the BHEL.
- f) Whenever BHEL exercise the authority to cancel the Contract under this conditions, BHEL may have the work done by any means at the Contractor's risks and expenses provided always that in the event of the cost of the work so done (as certified by BHEL,IVP Goindwal which is final and conclusive) being less than the Contract cost, the advantage shall accrue to the BHEL and if the cost exceeds the money due to Contractor under the Contract, the Contractor shall either pay the excess amount ordered by BHEL,IVP Goindwal, or the same shall be recovered from the Contractor by other means.
- g) In case the BHEL carries-out the work under the provisions of this condition the cost to be taken into account in determining the excess cost to be charged to the Contractor under this condition shall consist of the cost of the materials, hire charges of tools and plants and/or labor provided by the BHEL with an addition of such percentage to cover superintendence and establishment charges as may be decided by the BHEL, IVP Goindwal, whose decision shall be final and conclusive.

26) CANCELLATION OF CONTRACT IN PART OR FULL FOR CONTRACATOR'S DEFAULT:

If the Contractor:

- makes default in carrying out the work as directed and continues in that state after a reasonable notice from BHEL, IVP Goindwal, or his authorized representative;
- b) fails to comply with any of the Terms and Conditions of the Contract or after reasonable notice in writing with orders properly issued there under;
- c) BHEL, may without prejudice to any other right or remedy which shall have accrued or shall accrue thereafter to BHEL CANCEL the Contract as whole or in part thereof or only such work order or items of work in default from the Contract. Whenever BHEL exercise the authority to cancel the Contract as whole or part under this condition BHEL may complete the work at the Contractor's risk and cost (as certified by BHEL, IVP Goindwal official, which is final and conclusive) being less than the Contract cost, the advantage shall accrue to the BHEL. If the cost exceeds the moneys due to the Contractor under this Contract the Contractor shall either pay the excess amount ordered

by BHEL, IVP Goindwal or the same shall be recovered from the Contractor by other means. In case the BHEL carries out the work or any part thereof under the provisions of the conditions the cost to be taken into account in determining the excess cost to be charged to the Contractor under this condition shall consist of the cost of the materials, hire charges of tools and plant and/or labor provided by the BHEL with an addition of such percentage to cover the superintendence and establishment charges as may be decided by the BHEL,IVP Goindwal, whose decision shall be final and conclusive.

- **27) TERMINATION OF CONTRACT ON DEATH OF CONTRACTOR:** Without prejudice to any of the rights or remedies under this Contract, if the Contractor dies, or if the firm is dissolved or the company is liquidated BHEL shall have the option of terminating the Contract without compensation to the Contractor.
- 28) SPECIAL POWER TO TERMINATION: If at any time after the award of Contract, BHEL shall for any reason whatsoever not require whole or any part of the work to be carried out the BHEL, IVP Goindwal, shall give notice in writing of the fact to the Contractor who shall have no claim to any payment of compensation or otherwise howsoever on account of any profit or advantage which he might have derived from the execution of the work in full but which he did not derive in consequence of the foreclosing of the work.
- **29) RECOVERY FROM CONTRACTOR:** Whenever under the Contract, any sum of money, shall be recoverable from or payable by the Contractors, the same may be deducted from or any sum. then due or which at any time thereafter may become due to Contractor under the Contract or under any other Contract with BHEL or from his Security Deposit or he shall pay the claim on demand.
- **30) POST TECHNICAL AUDIT OF WORK AND BILLS:** BHEL reserves the right to carry out the post-payment Audit and technical examination of the work and final bill including all supporting vouchers, abstracts etc., and enforce recovery of any sum becoming due as a result thereof in the manner provided in the presiding sub-paragraphs. However, no such recovery shall be enforced after three years of passing the final bill.

31) PREFERENCES FOR MSE's:

- a) Preferences as mentioned in "Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012" shall be given to Micro and Small enterprises.
- b) Main points which are mentioned in the above order as applicable to this tender are as follows:
 - i) EMD shall be exempted for MSE's. All these benefits are subject to production of all statutory documents
- c) "MSE suppliers can avail the intended benefits only if they submit along with the offer, attested copies of either EM II certificate having deemed validity (five years from the date of issue of acknowledgement in EM II) or valid NSIC certificate or EM II certificate along with attested copy of a CA certificate (Format enclosed at Annexure -1 where deemed validity of EM II certificate of five years has expired) applicable for the relevant financial year (latest audited). Date to be reckoned for determining the deemed validity will be the date of bid opening (Part 1 in case of two part bid). Non submission of such documents will lead to consideration of their bid at par with other bidders. No benefit shall be applicable for this enquiry if any deficiency in the above required documents is not submitted before price bid opening. - **32) SUB-CONTRACT:** The purchase order or any part thereof shall not be sub-contracted, assigned or otherwise transferred without previously obtaining the BHEL's consent in writing.
- **33) FORCE MAJEURE:** If at any time during the continuance of the contract, the performance in which or in any part by either party of any obligations under the contract are prevented or delayed by reason of any war, hostilities, acts of public enemy, civil commotion, sabotage, fires, explosions, epidemics, quarantine restrictions, or acts of God (hereinafter referred to "an events" then provided the notice of happening of any such event is given by either party to the other within 21 days of the occurrence

thereof, neither party shall by reason of such event be entitled to terminate the contract nor shall either party have any claim for damages against the other in respect of such non-performance and delay in performance and delivery under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist. If the performance in whole or part of any obligation under the contract is prevented or delayed by reason of any such event, claims of extension of time shall be granted for periods considered reasonable by BHEL subject to prior notification by the vendor to BHEL of the particulars of the event and supply to BHEL, if required, of any supporting evidence. Any waiver of time in respect of partial installment shall not be deemed a waiver of time in respect of remaining deliveries.

- **34) DISPUTES:** In the event of any dispute and/or difference arising between the Vendor and BHEL as to interpretation and/or execution of the contract and/or the respective rights and liabilities of the parties, such disputes and/or differences shall be referred to the sole arbitrator nominated by BHEL. The provisions of the Indian Arbitration Act and the rules there under shall apply to such arbitration. The award passed by the arbitrator shall be final and conclusively binding on all the parties.
- **35) JURISDICTION:** The court of the place from where the work order is issued during the contractual period shall alone have jurisdiction to decide any dispute arising out of or in connection with the purchase order.
- 36) CLARIFICATIONS: The correspondence exchanged against the tender from both tenderer and BHEL through email/e-procurement are considered as valid document legally though it is not signed. It is treated as valid confirmations made on behalf of the respective company and very much comes under the legal ambit of the business transaction and hence it is binding on both the parties to the business. Any transaction pertaining to the tender from both the parties of business done round the clock irrespective of the office or business hours of the companies, are valid legally and binding on both the parties. This applies to the extent only in such cases where deadline time for transaction is not specifically declared by either or both the parties to the business.
- **37) BANNED FIRMS:** The offers of the bidders who are on the banned list as also the offer of the bidders, who engage in the services of the banned firms, shall be rejected. The list of banned firms is available on BHEL website www.bhel.com.
- **38) DISCLAIMER CLAUSE (Only for E procurement):** Neither the Organization (Bharat Heavy Electricals Ltd.) nor the service provider (Mjunction Services Ltd.) is responsible for any failure of submission of bids due to failure of internet or other connectivity problems or reasons thereof.
- **39) FRAUD PREVENTION POLICY:** The Bidder along with its associate / collaborators / sub-contractors / sub-vendors / consultants / service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website http://www.bhel.com and shall immediately bring to the notice of BHEL management about any fraud or suspected fraud as soon as it comes to their notice.

40) REVERSE AUCTION

- a) BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in nonconsideration of their bids, in case BHEL decides to go for RA.
- b) Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com).
- c) The bidders have to necessarily submit online sealed bid less than or equal to their envelope sealed price bid already submitted to BHEL along with the offer.
