2. Pre-qualifying Condition

The party should be financially sound and should have carry out more than 1 Lac contract value work in last three years either in public sector enterprises/BHEL Units. Also attached details of the maximum valued single Job, contractor handled so far with documentary proof.

3. Terms and Conditions

The contractor shall deposit an amount of 10% of the contract value as security with BHEL in the form of pay order/bank guarantee/FDR in the name of contractor A/C –BHEL duly discharge on the back. Alternatively, the amount of security deposit can be adjusted partly from EMD and balance amount from subsequent bills. However 50% of the SD will be deposited in cash/in the form of Demand Draft/bank guarantee and balance 50% can be recovered@ 10% from running bills. This security deposit shall be liable to be returned to the contractor after termination of the contract of at the end of it, subject to deduction on account of company dues, non-deposit of statutory dues etc. No interest shall be payable on the security deposit.

5. **Payment Terms:** Within 45 days after completion of work based on submission of invoice and work completion certificate issued by Authorised representative of BHEL CFP Rudrapur.

1. Taxes: TDS will be deducted as applicable.
