

**SCOPE OF WORK**

Painting work in BHEL Township quarters (40 nos. Quarters) as per BOQ for following mentioned Category of Quarters:

- a). HIG - 03 Nos. + 01 No.
- b). MIG - 20 Nos.
- c). LIG - 16 Nos.
- i). Removal of old painting/dirt (internal walls & ceiling) through rubbing using sand paper/wire brush and preparing the surface smooth including necessary repairs to scratches etc. complete.
- ii). Application of Paint (double coat) on walls (interior surfaces) & single coat on ceiling. Wherever required, more coats of painting shall be done to achieve even shade.
- iii). Application of Paint (double coat) on walls (exterior surfaces) at 01 no. HIG (Dispensary). Wherever required, more coats of painting shall be done to achieve even shade.

Note: a). Paint and putty will be provided by BHEL.

b). Workmen for the work, all tools & tackles, Paint brush, sand paper, wire brush, ladder, safety equipment's etc. shall be provided by the contractor.

## **TERMS & CONDITIONS**

- 1). The L-1 offer shall be decided on overall lowest price basis.
- 2). The work to be executed strictly under BHEL supervision, as per BHEL instructions and scope of work as and when required during General working shift (8:00 AM to 5:00 PM).
- 3). The work shall be done in BHEL- LIG, MIG & HIG Quarters at Awas Vikas, Rudrapur.
- 4). BHEL shall provide only paint and putty for the work. All tools, tackles, painting brush, wire brush, ladder & safety equipment's shall be provided by the contractor. Movement of manpower and materials shall be done by the contractor.
- 5). Water source at site shall be provided by BHEL to the contractor. Contractor shall be required to make suitable arrangement/pumping (as required) on its own to draw water from the source for exclusive use for execution of the contracted work.
- 6). Contractor should deploy adequate no. of person(s) for the work as required for execution/completion of work at its discretion. As per the nature/quantum of work and BHEL experience, the job shall be done by skilled and unskilled labour as a helper of skilled labour.
- 7). Delivery Schedule: The work to be completed in all respect within 120 days from the date of LOI or award of work whichever is earlier.
- 8). The co-ordination of work is to be ensured by the contractor during execution of work.
- 9). Poor workmanship is to be rectified to the satisfaction of BHEL by the contractor free of cost before site handover to / takeover by BHEL. Work not found as per specification (mentioned in item description at Annexure-III) shall not be considered for measurement and billing.
- 10). Inspection: Inspection of work executed by the contractor shall be carried out by BHEL at site.
- 11). Measurement of work: The work executed by the contractor shall be measured, recorded & verified at site jointly by BHEL & Contractor representatives and the same shall be entered in measurement book (M.B.). Unit of measurement for individual items shall be the finished area quantity as mentioned in Annexure-III. The area of incompletely painted quarters will not be measured for payment.
- 12). Payment Terms: Payment towards work satisfactorily executed will be made to the contractor through e-payment to contractor's account within 45 days of submission of bill & verification of work by BHEL.
- 13). Handing over / Taking over of site: Contractor shall hand over the site to BHEL after completion of work. BHEL shall take over the site after inspection based on satisfactory completion of work by contractor and measurement of work.



14). Risk Purchase: BHEL reserves the right to exercise risk purchase in case of failure on the part of contractor for meeting the contractual obligations under the contract w.r.t. unsatisfactory execution of work and/or quality, incomplete work carried out by the contractor & failure to meet delivery schedule. BHEL shall not be liable to compensate the contractor for any loss arising out of risk purchase action.

15). Liquidated DAMAGES/PENALTY: If the contractor fails to maintain the required progress of work resulting in delay in the completion of the work against delivery schedule, BHEL shall have the right to impose Liquidated Damage / Penalty at the rate of 0.5% of the contract value, per week of delay or part thereof subject to a maximum of 10% of the contract value. For this purpose, the period of delay shall be the delay attributable to the Contractor for the completion of work as per contract. Contract Value for this purpose, shall be the final total non-executed value of contract.

16). Time Extension : In case, the work is delayed due to Force majeure conditions like, abnormally bad weather, serious loss or damage by fire, civil commotion, strike or lockout, flood, riots, cyclone, earthquake etc. any other cause including non-availability of storage / delay in site clearance for work by BHEL, which in the absolute discretion of BHEL is beyond the contractor's control, request for extension of time along with reason(s) to be eligible for consideration, shall be made by the contractor in writing within seven days of the happening of the event causing delay but before expiry of scheduled date of completion. BHEL may or may not, at its discretion, give any extension after review of contractor's application and mere submission of application for extension shall not absolve the contractor of its obligation to complete the work within scheduled time or liable to be penalized for delay unless time extension is provided by BHEL. Status on grant / turndown of extension request shall be communicated to the contractor.

17). Warranty & Security Deposit: Onsite warranty of 3 months against defective workmanship shall be applicable from the date of completion of work against contract. Any defect in workmanship detected during warranty period shall be rectified free of cost by the contractor. Contractor shall be required to deposit an interest free security deposit @5% of contract value before start of the work, which shall be retained by BHEL during warranty period.

18). Contractor shall take due care in carrying out the works so as not to cause damage to BHEL property. Any damage to BHEL property caused and attributed to the contractor or its workmen shall be repaired / 100% compensated by the contractor at its risk & cost.

19). The contractor shall be fully responsible for the acts/omissions by the persons engaged by it for working at BHEL premises under the contract. The person engaged by the contractor should not have any criminal record/ or involved in any activity subversive of law and order. The contractor shall be liable to compensate for any damage to person/ property of BHEL/ third party by its person(s) within BHEL premises.

20) Quantity of work for any or all of the activities may vary by 10 % depending upon the occupancy of quarters and decision of BHEL.
