Bidder shall comply to all the additional clauses mentioned in Bid Document. The offers of those bidders who do not comply with all the clauses in total are likely to be rejected.

SPECIAL TERMS AND CONDITION

1) DURATION OF CONTRACT:

- a) The period of contract is **TWO Years** from the date of PO with all the required certificates/documents (as applicable) for regular usage.

2) DELIVERY SCHEDULE:

- a) Erection & Commissioning of bullets/portable cylinders (whichever is applicable) shall be completed within 3 months from the date of PO.
- b) Bidder shall ensure staggered supply of liquid argon as and when required by BHEL for a period of **2 years from date of PO**. Quantity Requirement will be intimated by BHEL through mail then and there and supply shall be effected within 2 days from the date of intimation.
- c) For the installed equipment, fixed facility charges will be made in monthly basis.
- d) Scope of work includes design, transportation, erection, commissioning, supply, maintenance, calibration, inspection, getting/renewal of necessary statutory license for LAR system and supply of liquid argon.

3) PRICE VARIATION CLAUSE

- a) Fixed price: Prices quoted by the bidder shall be fixed and not subject to any escalation whatsoever during the period of bid validity and execution of the Purchase Order. A bid submitted with an adjustable price will be treated as non - responsive and rejected.

4) LIQUIDATED DAMAGES (LD):

- a) For Monthly rental charges:
 - i) On the occasion of breakdown of the system, bidder should depute their engineer within the minimum possible time and restore the system back to normal operation. In case failure of the system occurs for more than 24 Hrs, penalty @ 2% per day will be charged on the monthly fixed facility rate of that tank/portable cylinders and the same will be deducted from the monthly invoice raised by the bidder.
- b) For Mobilization, Erection and Commissioning:
 - i) If the contractor fails to complete the Mobilisation, Erection and Commissioning of a particular bullet/portable cylinder as per terms & conditions of the order within 3 months from PO date, Purchaser shall deduct Liquidated Damages @ 2% per day on the monthly fixed facility rate of that tank/portable cylinders and the same will be deducted from the subsequent monthly invoice raised by the bidder.
- c) For supply of Liquid Argon

mail then and there and supply shall be effected within 2 days from the date of intimation. If supplies are not effected within 2 days of intimation from BHEL, then LD shall be recovered at 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre estimated damages not exceeding 10% of the contract value of delayed quantity.

- (i) LD will be reckoned from the delivery date to the date of vehicle receipt at BHEL HPVP.
- (ii) Under GST regime, BHEL has to discharge GST liability on LD recovered from suppliers/ contractors. Hence applicable GST shall also be recoverable from suppliers/ contractors on LD amount. For this Debit note will be issued by BHEL indicating the respective supply invoice number.

5) TERMS OF PAYMENT:

- a) All payments to be made to the contractor, shall be through NEFT (National Electronic Fund Transfer) / RTGS (Real Time Gross Settlement) within reasonable time, as given below, after the certification of bills by the end user / executing agency.

- b) Monthly fixed facility charges become payable after the issue of Commissioning Certificate by BHEL HPVP.
- c) Monthly fixed facility charges become payable at the end of each Month after certification by Engineer in charge, BHEL HPVP. Bidder shall submit the invoice after each Month. 100% monthly fixed facility payment will be made as per the above terms from the date of certification.
- d) No separate payment will be made for periodic visits, maintenance works, spares during the contract period and for taking back of the LAR System.
- e) For LAR Supply: 100% payment will be made, as per the above terms, from the date of gate/vehicle entry at BHEL, subject to online submission of bills and acceptance of materials.
- f) Supplier shall mention their GSTN registration number in all their invoices and invoices shall be in the format as specified/prescribed under GST laws for processing the bills on monthly basis.
- g) Statutory deduction like IT etc. will be deducted from contractor payment as required by Law.

6) PERFORMANCE SECURITY DEPOSIT:

Preamble

____. The Principal values full compliance with all relevant laws of the land, rules and regulations, and the principles of economic use of resources, and of fairness and transparency in its relations with its Bidder(s)/ Contractor(s).

1. Section 1- Commitments of the Principal

1.1. The Principal commits itself to take all measures necessary to prevent corruption and to observe the following principles:-

1.1.1. No employee of the Principal, personally or through family members, will in connection with the tender for, or the execution of a contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.

- 2.1.2. The Bidder(s)/ Contractor(s) will not enter with other Bidder(s) into any illegal or undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
- 2.1.3. The Bidder(s)/ Contractor(s) will not commit any penal offence under the relevant Indian Penal Code (IPC) and Prevention of Corruption Act; further the Bidder(s)/ Contractor(s) will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
- 2.1.4. Foreign Bidder(s)/ Contractor(s) shall disclose the name and address of agents and representatives in India and Indian Bidder(s)/ Contractor(s) to disclose their foreign principals or associates. The Bidder(s)/ Contractor(s) will grant the monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his contract documentation. The same is applicable to Subcontractor(s). The Monitor is under contractual obligation to treat the information and documents of the Bidder(s)/ Contractor(s) / Sub-contractor(s) with confidentiality in line with Non- disclosure agreement.
