PRE-QUALIFYING CRITERIA (PQC)

A. The tenderer should be our PMD vendor of our PMD WEX009/10 for 'CENTRIFUGING OF OIL OF TRANSFORMER & REPAIRING OF TRANSFORMER'.

Or

- B. 1. Average annual financial turnover during the last 3 years, ending 31st March of the previous financial year, should be at least 30% of our estimated cost i.e. Rs.14,100.00
 - 2. Experience of having successfully completed similar works in any Central/ State organization/ enterprise/institute/undertaking/ autonomous body/corporation only during last 7 years ending 31.12.2020 and should be either of the following: -
 - a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost of Rs.47000.00

Or

b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost of Rs.47000.00

Or

c) One similar completed work costing not less than the amount equal to 80% of the estimated cost of Rs.47000.00

Similar works means

"Centrifuging of Oil of Transformer & Repairing of Transformer"

Note: -

- BHEL HERP PMD Contractors as per category based on value of work shall be exempted from submission of documents related to PQC as mentioned above. They should only submit documents mentioned at point no 3, 4 & 5 of Part-I Technical Bid as mentioned in DIRECTIONS TO PARTIES FOR TENDERING.
- 2. Copy of work order or completion certificate or Commissioning certificate or MOM (confirming completion or Commissioning of work) or handing over certificate from Bidder's customer for similar works shall be submitted in Techno-commercial bid. BHEL reserves the right to verify the contents of given certificate. Complete postal address, name of contact person, phone no. & email address of issuing authority is to be submitted by the Bidder in Techno- commercial bid. In case BHEL intends to visit Bidder's customer, the same shall be facilitated by Bidder (expenditure of visit of BHEL official shall be borne by BHEL).

Special Terms and Conditions

SI.	Description
1	The centrifuging of transformer oil and transformer overhauling is to be carried out for 1MVA, 33/0.4
	kV oil cooled transformer Crompton Greaves make at BHEL, HERP, Tarna, Shivpur, Varanasi
2	Parties are advised to visit the site before bidding to assess the nature and quantum of work.
3	All items supplied by the party shall have to get approved by the engineer-in-charge before use.
4	All T&P including temporary piping required for centrifuging of transformer oil is to be arranged and installed by the party. BHEL will provide one single phase/three phase power point and fresh transformer oil free of cost however party shall have to arrange its own power cables etc. to run its equipment.
5	Party has to get transformer oil tested for BDV before and after centrifuging the transformer oil and submit report.
6	Party to ensure minimum BDV of 40 kV after centrifuging as per IS 1866:2000
7	The quantities of each item of BOQ may vary depending upon the site condition and actual requirement.
8	The contractor will execute the work as per instructions of engineer-in-charge.
9	Work Completion Period: Work should be completed within 30 days from the date of award of contract/LOI.
10	Party should clear the site within 2 days after completion of work. All defective parts/items shall be property of BHEL and shall be returned to Maintenance deptt. after completion of work.
11	It is the responsibility of the contractor to ensure safe working of his workers while carrying out the work and should follow all the Statutory safety precautions and rules. Contractor should provide and ensure use of Personal Protective gears by his worker for safe working.
12	In case of any accident causing injury or casualty to any of Contractor's worker or Contractor himself while carrying out the work, the complete responsibility lies with the Contractor
13	Contractor should ensure to provide immediate medical help to his injured worker(s) and should provide compensation as per U.P. Govt. Workmen's Compensation Act, 1923' in case of injury or casualty while on work.
14	Miscellaneous Charges : Accommodation charges, to & fro travel expenses, freight from party works to HERP, Varanasi and supervision & labour charges as miscellaneous charges (if any) shall be paid as quoted in bid by bidder and same shall be considered in preparing CST (Comparative Statement).
15	Payment terms: 1. Payment shall be made through EFT within 30 days on receipt of Tax Invoice only after satisfactory completion of the work.
	2. All statutory taxes & levies shall be deducted from the payment, as per prevailing government rules.
16	Security Deposit: The party has to submit requisite Security Deposit within 15 days of award of work. The amount of security deposit shall be confirmed in the LOI/award of contract.
17	Warranty Clause: There shall be six month warranty against material used and workmanship of the party. The date of warranty shall be calculated from the date of the date of completion of work.
18	L.D. Clause: If party fails to complete the work within 30 days, penalty against the late delivery clause shall be implemented at the rate of 0.50%per week limited to maximum limit of 10% applicable on the total Contract value.
19	All vendors registered under GST must submit the details of GST registration. Such vendors should mention separately appropriate GST rate as extra in their offer/invoice for each item. Vendors not covered under GST must inform the same to BHEL in writing on their letter head with supporting document.
20	Copy of general conditions of contract running in total 26 pages will be applicable on this contract. If there is any difference between general conditions of contract and special terms and conditions then special terms and conditions shall be applicable.
