- The works shall be executed with the directions, instructions, which shall be given to the contractor
 by BHEL from time to time and as per technical specifications in price schedule and drawings
 available in the office to give a general idea of the work to be executed and is liable for modifications
 during the actual execution based on the designs prepared and approved by the Competent
 authority.
- 2. If the specifications found wanting relevant technical specifications along with the tender shall be followed. Further missing details relevant CPWD and IS specifications shall be followed. Wherever, there is difference in between CPWD and IS specifications latter shall prevail.
