B-SCOPE OF WORK:

- 1.1 Repairing/overhauling of fork lift engine shall be done in party's work-shop.
- 1.2 All the spares of engine to be used for repairing /overhauling shall be issued by BHEL free of cost to the party, with the every engine on returnable basis.
- 1.3 Defective items/spares shall be return back to BHEL after completion of total work and a joint inspection by BHEL at vender's work-shop.
- 1.4 The repaired/overhauled engine shall be covered under a warrantee for a minimum period of 06 months.
- 1.5 Transportation of damaged and repaired/overhauled engines shall be arranged by the party.
- 1.6 Damaged engine shall be issued to the party through returnable material gate pass (only one engine in a time) by Fork lifter Maint Ctr. of Factory.
- 1.7 Next damage engine of fork lifter shall be issued to the party by BHEL only after handing over the previous repaired engine to BHEL, by the party.

3. URGENT WORK.

The party shall have to comply with the priorities fixed by the section in charge for taking urgent repair work.

4- CANCELLATION OF CONTRACT IN FULL OR PART.

- 4.1 Contract shall be cancellation in full or part if the contractor:
- 4.2 At any time makes defaults in proceeding with the work with due negligence and continuous to do so after a notice in writing or 7 days from the AGM (WE&S) BHEL, Jhansi

- 1.2) If all balance sheets are not available for all three years than the average shall be calculated by dividing the sum of turnover of submitted balance sheets by three.
 - Bidder not having statutory obligation to get financial statement audited must submit following documents as evidence for turnover:

a. A certificate from CA duly vetting turnover.

- b. Audited balance sheet & profit and loss amount.
- 2. Experience of having successfully completed similar work (means Repairing/overhauling of Automobile Engine) during last 7 years from the previous month of floating of tender should be either of the following:-
- a. Three similar completed works contracts during last 7 years from the previous month of floating of tender each costing not less than the amount equal to Rs. 0.53 Lakh.

b. Two similar completed works contracts during last 7 years ending from the previous month of floating of tender each costing not less than the amount equal to Rs. 0.67 Lakh
