- 1.7 Next damage engine of fork lifter shall be issued to the party by BHEL only after handing over the previous repaired engine to BHEL, by the party.

 - 1.2) If all balance sheets are not available for all three years than the average shall be calculated by dividing the sum of turnover of submitted balance sheets by three.

 - a. A certificate from CA duly vetting turnover.
 - OR
 - b. Audited balance sheet & profit and loss amount.
2. Experience of having successfully completed similar work (**means Repairing/overhauling of Automobile Engine**) during last 7 years from the previous month of floating of tender should be either of the following:-
 - a. Three similar completed works contracts during last 7 years from the previous month of floating of tender each costing not less than the amount equal to Rs. 0.53 Lakh.

 - b. Two similar completed works contracts during last 7 years ending from the previous month of floating of tender each costing not less than the amount equal to Rs. 0.67 Lakh
