SCOPE OF WORK:

- 1. Operation of Voltas Make Screw Chiller based Air-Conditioning plant: Vendor to ensure operation of 03 numbers Screw chiller based air-conditioning plant installed at Bay-11 (new winding shop) in A and B shift. Operation in C shift may also be ensured as and when required by BHEL.
- 2. <u>Breakdown maintenance of Screw Chiller based Air-Conditioning plant</u>: All the breakdowns shall be recorded in log book and same shall be attended on day to day basis. If any breakdown is pending due to spares requirement or for any major work involved, same shall be informed to the section in-charge. Vendor to maintain and keep proper record of all the attended breakdowns.
- **3. Operation of Air Washer unit:** Vendor to ensure operation of 03 numbers Air Washer units of 7200 CFM installed at Bay-6 in A and B shift. Operation in C shift may also be ensured as and when required by BHEL.
- **4. Break down maintenance of Air Washer Units:** All the breakdowns shall be recorded in log book and same shall be attended on day to day basis. If any breakdown is pending due to spares requirement or for any major work involved, same shall be informed to the section in-charge. - **5. Routine Maintenance of plants**: Routine maintenance of the plants and air washer units shall be carried out on daily basis by the vendor as instructed by section in-charge.
- **6.** Descaling of shell and tube condenser/ heat exchanger of Screw chiller based air-conditioning plant shall be done once in a contract period. Chemical needed for cleaning of shell and tube condenser shall be provided by BHEL.
- **7. Pro-active measures towards daily operation of plant:** Following proactive activities shall be ensured by the vendor regularly before and after operation of the plants / air washer units. Vendor to maintain proper record of proactive activities done.
 - **6.1** Checking of leakage in refrigeration line.
 - **6.2** Keeping the plant / equipment and AHU unit room clean and in good working condition.
