- 1. Rewinding & repairing of 3-Phase and Single Phase Motor:** Scope for rewinding and repairing of 3 phase and single phase motors are mentioned below & for the detail of work refer annexure-B.
  - 1.1** Rewinding and repairing of all motors shall be done in party's work shop.
  - 1.2** All the material used by party in motor rewinding including winding wire, insulating material and insulating varnish etc. should be of a good quality.
  - 1.3** All re-winded or re-winded & repaired motors shall be covered under a guarantee for a minimum period of 06 months.
  - 1.4** Transportation of damaged and re-winded / repaired motors shall be arranged by the party.
  - 1.5** Damaged motors shall be issued to the party through returnable material gate pass by Test Plant Maintenance Center of Factory.
  - 1.6** Fresh damaged motors shall be issued to the party by BHEL only after handing over the previous Re-winded motors to BHEL by the party.
  - 1.7** Burnt copper wires of damage winding will be at bidder's disposal. However, this shall be taken care of while quoting the rates in their offer for item no. 1 to 16 of BOQ. Approximate weight of fresh copper needed for rewinding and approximate weight of burnt copper recovered after rewinding against individual motor is mentioned in Annexure-C.
  - 1.8** The vendor needs prior permission of the BHEL wherein repairing of motor housing & shaft (price schedule clause SL-21, 22 & 23) is needed along with rewinding.
  - 1.9** The vendor needs prior permission of the BHEL wherein replacement of shaft & bush (price schedule clause SL-20) is needed along with rewinding.

**2. Rewinding & repairing of ceiling fan motors:** Scope for fan motor rewinding and repairing is mentioned below and for the details of work refer annexure-B.

**2.1** Rewinding of ceiling fan motors shall be done in party's work shop.

**2.2** All the material used by party in ceiling fan motor rewinding including winding wire insulating material and insulating varnish etc. should be of a good quality.

**2.3** The re-winded or re-winded & repaired ceiling fan motors shall be covered under a guarantee for a minimum period of 06 months.

**2.4** Transportation of damaged and re-winded/ repaired motors shall be arranged by the party.

**2.5** Damaged ceiling fan motors shall be issued to the party through returnable material gate pass (in a lot of maximum 20 ceiling fan motors) by Test Plant Maintenance Center of Factory.

**2.6** Fresh lot of Damaged ceiling fan motors shall be issued to the party by BHEL only after handing over the previous lot of re-winded/ repaired ceiling fan motors to BHEL, by the party.

**2.7** Burnt copper wires of damage winding will be at bidder's disposal. However, this shall be taken care of while quoting the rate in their offer for item no 17 of BOQ. Approximate weight of fresh copper needed for rewinding and approximate weight of burnt copper recovered after rewinding against individual motor is mentioned in Annexure-C (Item SL-17).

**2.8** The vendor needs prior permission of the BHEL wherein either repairing of motor housing or repairing of shaft (price schedule clause SL-19 &18) is needed along with rewinding.

**3. Special Remark:**

**3.1** In the contract, provision of CLRA will not be applicable.

**3.2** GST shall be paid extra as applicable.

**4. Urgent Work:** The contractor shall have to comply with the priorities fixed by the maintenance in charge for taking urgent rewinding work other than schedule rewinding work.

**5. Period of Contract:** The period of contract will be for twelve months from the date of issue of work order or till the completion of work.

**6. LD clause:** Vendor need to return all the re-winded / re-winded & repaired motors within 30 days from the date of issue (motor will be issued through returnable material gate pass) of motor. ## **SPECIAL TERMS & CONDITIONS**

1. The contract shall be divided between L1 & L2 bidders in the ratio of 60:40.
2. All the eligible bidders will be categorized from L1 to Lh bidder (Lh will be the bidder who quoted highest rate) on basis of their quoted rates. In case of equal rates at the same level, a toss/lottery shall be drawn among all the contractors having quoted equal rates for grading from lower to higher rates. This list shall be referred for award of work. L1 bidder shall get the 60% of work, whereas after counter offer (if required), L2 shall get 40% of the work at the L1 rate. In case L2 bidder declines to accept the offered L1 rate, the criteria for award of work at the L1 rate will shift to the next higher eligible bidder and so on.
3. In case no eligible bidder accepts counter offer at L1 rate, the entire contract shall be awarded to L1 bidder.
4. The quantity of each individual item given in the above price schedule is tentative and is only for evaluating the total cost of the work. During the execution of the contract, the quantity of individual items allotted to the vendor may vary in any ratio, but it will be restricted to the total contract value allotted to the vendor.
