TENDER NOTICE

TENDER NO. BHEL/ADMIN/SHOPS/01/2026-27

Sealed **Two-Part Bids** are invited by the Estate Officer for Licensing of shop premises in different trades situated in various sectors of the company's township as detailed below subject to the terms and conditions detailed in this Tender Notice. The tenderers shall submit their offer along with this document signed on all pages as acceptance of each of the terms and conditions listed.

DETAILS ARE AS FOLLOWS:

Place	Description of Shops furnished in ANNEXURE - A
Type of Space	Built up space covered with mostly RCC roof.
License Fee	License Fee shall be fixed by Tender. Minimum Reserve License Fee Rs. 34.54/- per Square Meter per month for shops in A & B Sectors, Rs. 24.69/- per Square Meter per month for shops in C Sector and Rs. 39.25/- per square Meter per month for shops in K Sector. The final License Fee shall be fixed based on valid bids and the price quoted.
Periodicity of Payment	License Fee together with allied charges (GST & Water charges wherever applicable) shall be payable every month in advance at the beginning of the month.
Tax	GST @ 18% or at the applicable rates payable on the License fees to be borne by the occupant.
Security Deposit	Successful bidders will have to pay 12 months License fee as security deposit.
EB Charges	EB charges have to be borne by the successful tenderer during the period and should be remitted of their own as per meter reading. EB deposit also to be borne by the successful tenderer. Any increase in rates proposed by TANGEDCO will have to be borne by the occupant.
Water Charges	As fixed by BHEL based on consumption has to be paid in addition to the license fees.
Period of Allotment	Initial License Agreement will be made only for a maximum period of 5 years. During the currency of this Agreement, the License Fee shall stand enhanced on each yearly anniversary of Agreement @5% which shall be rounded off to the next higher ten Rupees. Thereafter subsequent renewals limited to two times only may be permitted for maximum 5 years' period each time subject to compliance of the terms & conditions of such allotments as specified in the License Agreement. During renewed agreement period also, the License Fee shall stand enhanced on each yearly anniversary of Agreement @5% which shall be rounded off to the next higher ten Rupees.

TERMS & CONDITIONS

1. Earnest Money Deposit:

Each Tender must be submitted together with a Demand Draft drawn on any Nationalized Bank in favour of “Bharat Heavy Electricals Limited” payable at Tiruchirappalli-14 for the value specified against each shop (given in **ANNEXURE-A**) towards Earnest Money Deposit (EMD). EMD can also be paid through SBI e-collect or through EFT. **Tenders received without DD/SBI e-Collect or EFT Receipt for Earnest Money Deposit shall be summarily rejected.** Cheques will not be accepted. The Demand Draft towards EMD amount may be kept in a separate envelope.

Earnest Money deposit of unsuccessful tenderers shall be refunded after expiry of validity period of the tender. In the case of successful tenderer, earnest money deposit will be adjusted towards the Security Deposit or it may be forfeited in case the successful tenderer refuses to accept the award of license or fails to complete the required formalities and occupy the premises within the specified and permitted time, and delay in starting the actual operation beyond the permitted time. **MSE benefits (exemption from EMD only for Micro & Small) will be provided in case of submission of Valid UDYAM Registration Certificate** provided the following conditions are fulfilled.

- A) Referring to OM dtd 09.02.2021, Under MSE category, only manufacturers for goods and Service Providers for Services are eligible for exemption from EMD. Traders are excluded from the purview of this Policy. EMD is applicable for Traders participating in tender even though they are having valid Udyam certificate.
- B) Exemption from EMD only for Micro & Small Industries only. But if upward graduation from small to medium is within 3 years from such re-classification, they are exempted from EMD

2. Security Deposit:

Successful bidder shall deposit a sum equivalent to 12 months' license fee as Interest Free Security deposit and the same will be returned without interest after the license period is over and after vacant possession of the building is handed over by the occupant. Refund will be subject to full settlement of dues payable to company, and adjustment against damages, if any.

- 3. Selection of successful Bidder shall be made by Township Shops Tender cum Allotment Committee appointed by BHEL. The technical bid will be opened on the specified date and the tenderers will be evaluated to find the suitability. The financial bids of the technically accepted offers will be opened on a date to be specified later. The successful bidder will be selected, based on the highest rate of License Fee offered.
- 4. Allotment of one premises does not debar the allottee from applying for another (second or subsequent) premises for which tender process is initiated. However, in no case the allottee can have more than **three concurrent licenses** for shops. If a bidder is in possession of three licenses on the close date of submission of tender, his/her bid for the fourth and subsequent licenses will be summarily rejected.
- 5. Tenderer, in his own interest, should inspect the proposed premises / place before submitting tender.
- 6. The Shop(s) will be allotted to the Successful Tenderers on “**As-Is-Where-Is basis**”. They will not be paid any compensation, damages towards dismantling, removal of any infrastructure, temporary structures, interiors etc., which they may have done after allotment for running the trade/business during the license period at the time of expiry/termination of license/vacation of premises on account of any reasons whatsoever.

7. The successful tenderer shall have necessary licenses as required by Govt. authorities/statutory authorities for running the proposed shop.

8. The tenderer shall submit the following and will form the main part of tender document:

- a) DD/SBI e-collect receipt/EFT receipt for EMD and EMD Format (**Part-A**) given in Page 6 of this document filled up with details, affixed with signature, both up put in an envelope (Envelope-1) sealed and super scribed as **Tender for shop no ____ EMD.**
- b) Technical bid (**Part B**) given on page 7 & 8 of this document filled up with details, affixed with signature, put up in an envelope (Envelope-2) sealed and super scribed as **Tender for shop no ____ Technical Bid.**
- c) Price Bid (**Part C**) given on page 9 of this document. filled up with details, affixed with signature, put up in an envelope (Envelope-3) sealed and super scribed as **Tender for shop no ____ Price Bid.**

*** Bidders are requested to exercise utmost caution while filling up the Quote in Price Bid.**

*** All the pages of the tender document have to be duly signed by the tenderer.**

Envelope -1 & 2 to be put up in one Cover and Envelope-3 in a separate cover and both the Covers to be put in One big cover, with inscription on the top left side "**Tender for Shop No.----- -- for----- (Business name)**" sealed and dropped in the tender box placed in the Tender Cell (Room No.26) located in Admin building (24 Bldg) on or before **02:00 pm on 07.08.2026.**

The management shall not be responsible for any loss or delay in receipt of the tender sent by post/courier. The tenderer's name, address, phone number, mobile number and e-mail id, if any shall be written on the left side of the sealed cover, without fail. The tender bid shall be legibly written, and any bid lower than the reserve license fees shall be summarily rejected.

9. The technical bids will be opened on **07.08.2026 at 02:30 pm** in the presence of those tenderers who wish to be present. For any failure to intimation due to incomplete/incorrect address/phone no: /e-mail id etc. or otherwise, BHEL shall not be responsible. **It shall be the primary duty of the tenderer to enquire and attend the proceedings.**

10. The Price bids of the offerers who are technically qualified will be opened on a later date to be specified by the company.

11. Successful Tenderer shall complete all formalities within 15 days from the date of information including deposit of security deposit and execution of License Deed prescribed by BHEL and shall start his business within 60 days from the date of allotment of building. On failure to commence business within the said 60 days, the Tender shall stand cancelled and the loss suffered by BHEL in this regard shall be appropriated from the Earnest money/Security deposit deposited by the Tenderer.

12. **Payment of License Fee on allotment and during running of shop**

(a) The successful Tenderer should pay three months License fee in advance in addition to the security deposit (12 months License Fee). Both payments should be made through SBI e-collect. ***It is to be noted that, the monthly License Fee/Security Deposit will be calculated by rounding off the amount to the next higher ten rupees.***

(b) The successful Tenderer should give ECS mandate at the time of allotment for payment of their license fee through the bank in which they are operating their account and should be alive till the date of surrender/taking over of the shop. On receipt of the ECS mandate only, allotment will be done.

- (c) The successful Tenderer/allottee should maintain the stipulated License Fee /Month along with GST in his ECS linked bank account by 07th of every month which is apart from the minimum balance advised by the respective banks. It should be noted that penalty will be levied by the banks to the defaulters who does not maintain the License Fee with GST when ECS is operated.
- (d) In the event that the ECS cannot be operated due to a dormant or inactive account, administrative action will be initiated against the allottee by BHEL.
- (e) Interest @ 1.50% per month shall be calculated and will be collected in cases of any delay in remitting monthly rent after 7th of following month.
- (f) In addition to the above, If the license fee remains unpaid for three consecutive months (excluding the three-months Licensee fee paid in advance), BHEL will initiate administrative action against the allottee which may include taking over the shop in accordance with the Public Premises Eviction Act. ***Payment of License Fee dues afterwards will not be entertained once Public Premises eviction act procedures are initiated. The Security Deposit will also be forfeited.***
13. Tenderer should declare about the employment of any terminated/dismissed employee of BHEL/Government/Govt. Organizations. This declaration should be made on a separate sheet and form part of this document.
14. The shop premises allotted shall be utilized for running the specified business/trade only and shall not be used for any other purpose/business without the written consent of BHEL. The License granted shall not be Sub-licensed either fully or in part to any third parties.
15. Shops shall be run effectively and shall not be closed except on weekly holidays /public holidays. Shops shall not be kept open beyond the specified timings.
16. The Price of goods proposed to be sold or the fee for the services to be rendered shall be exhibited in front of the Shop Premises.
17. The period of License will be for five years. During the license period, the license fee will be increased every year by 5%. BHEL may at its discretion consider renewal after 5 years, subject to the other party requesting for the same in writing 6 months in advance of completion of 5-year contract period and agreeing to BHEL's terms and conditions and revised license fee. However, failure or delay exceeding one month on the part of the tenderer to pay the license fees shall confer a right on BHEL to terminate the License without further notice to the Tenderer.
18. Compliance with the various statutory requirements, norms and rules and regulations prescribed will be the responsibility of the licensees including the financial implications thereof. The successful Tenderer, before the commencement of business, shall timely obtain all licensees such as Trade License, Eating House License and all ancillary licenses/ permissions/ clearances that may be required to be obtained by the Licensee from any authority/authorities at their own cost for the operation of the outlet. The successful tenderer shall solely be responsible to ensure and keep such Licenses valid throughout the license period.
19. The successful tenderer or his employees shall maintain harmony in the township and shall not indulge in any illegal activities in the township premises. In case of any such event /activities detrimental to company's interest/decency/morality etc., the company shall have the right to terminate the agreement on one week's notice.

20. The successful tenderer should ensure that all the wastes generated from the allotted shop due to the business activities should be properly disposed of at regular intervals and not to be dumped around the shop or nearby areas or else the company shall have the right to initiate administrative actions and terminate the agreement if the allottee fails to do so.
21. All taxes and Government levies as applicable from time to time like expenditure tax, entertainment tax, sales tax etc. if any will be payable over and above the amount of license fee.
22. The tenderer shall take comprehensive insurance to cover all type of damages to his/her property, his/her staff, stocks, stores, spares, equipment, etc. No additions/alterations are to be carried out in the licensed premises without the prior permission of BHEL. Additions/alterations, if done, are to be of temporary nature and should be removed at the time the license period is over.
23. Model license Deed will be provided by BHEL for execution to the successful tenderer on allotment. License Deed to be furnished in Non-Judicial Stamp Paper of sufficient value by the licensee.
24. The Blank Tender application form can be downloaded from BHEL web site, filled up, and should be kept along with the Demand Draft /SBI e-collect or EFT receipt drawn towards EMD. **If the DD/SBI e-collect receipt/EFT receipt for EMD is not enclosed, the application will be rejected.**
25. In order to facilitate the refund of EMD to the unsuccessful bidders, the tenderer has to fill up the RTGS form attached with this Tender document (given in Annexure-D), get it signed from the Branch Manager of the Bank, where he /she is maintaining the savings/current account. and is to be attached with the Technical Bid of Tender Document along with a copy of front page of the Bank pass book.
26. The Tender document containing DD/SBI e-collect/EFT receipt for EMD with EMD Format, Tech Bid, Price Bid duly filled in and signed up, along with self-attested Terms & Conditions and DD/SBI e-collect/ EFT receipt for application fee all should be submitted through post or in person at the following address on or before **02:00 pm on 07.08.2026.**
