



1. **The First envelope** shall contain Part-I (Technical bid documents shall be signed on all the pages and affix vendor's seal) and shall be sealed and super scribed as Part-I (Technical Bid for NIT/Enquiry No. and name of the supply).
2. **The second envelope** shall contain only Part-II (Price bid) for the above supply and to be quoted as per the format given in price bid. Any other information in price bid will not be considered. The envelope shall be sealed and super scribed as Price Bid for NIT / Enquiry No and name of supply. **Price bid should not be clubbed together with Technical bid.**

All the above Two envelopes shall be kept into one cover, sealed and super scribed as Tender Document for the work as per NIT (NIT/Enquiry No. and name of the work).

The Tender (envelope containing Part I & II) should reach The Tender Opening Cell / MM on or before the due date and time. These documents should be sent either by Registered post / Speed Post / courier / in person. Tenders received after due date and time will not be considered for evaluation.

3. Any deviation to this tender terms & conditions and schedules of this tender will lead to total rejection of the offer submitted.
4. Contract will be awarded for a period of **one year** from the date of award of contract and supply rate shall remain firm for the entire period of the contract.
5. **Price bid shall be valid up to Three months from date of Tender opening.**
6. Rates should be quoted as per Price Bid Format only and the Rate quoted is inclusive of GST, other Taxes if any, Transportation, Loading, Unloading, etc.No additional claim will be allowed. Rates quoted in any other form will not be accepted and will be rejected.
7. Any change in applicable rates of Tax or any other statutory levies (Direct / Indirect) or any new introduction of any levy by means of statute and its corresponding liability for the deliveries beyond the agreed delivery date for reasons not attributable to BHEL will be to vendors account. BHEL will not reimburse the same and any subsequent claim in this respect will be summarily rejected.
8. **BHEL does not guarantee any minimum quantity.**
9. No other pre conditions along with your offer will be entertained by BHEL.
10. Tenderer who have been suspended or black listed or issued with "Show Cause Notice" by BHEL, Tiruchirappalli - 620014 or any other unit of BHEL or Government of India will not be allowed to participate in the tender. Even during the course of evaluation/ finalization of tender if it is found that some of the parties are black listed/ barred from business transaction/ under business hold, BHEL will not consider them for further participation in the tender.
11. Should a tenderer find discrepancies or omissions in the tender documents or should there be any doubt as to their meaning, he should at once address the authority inviting the tender for clarification well before the due date, so as to submit his tender in time. No extension of time shall be given for submission of the tender on any account.
12. **All pages of this tender documents and supporting documents shall be dully signed, stamped and Submitted as technical bid.**
13. **Documents not signed and stamped by the authorized signatory of the bidder shall not be accepted and considered for evaluation of bid.**
14. If a tenderer deliberately gives wrong information in his tender or creates conditions favorable for the acceptance of his tender, BHEL will reject such tender at any stage.

15. Words imparting singular number shall be deemed to include plural number and vice-versa where the context so requires.
16. Canvassing in any form in connection with tenders is strictly prohibited and the tenders submitted by the Contractors who resort to canvassing will be liable for rejection.
17. The tender schedule and the tender shall be deemed to form an integral part of the contract to be entered into for this work.
18. **Tenderer shall sign and affix the seal in the tender documents for having accepted the conditions and submit the same along with Technical Bid. 19. Tender can be cancelled at any stage due to unavoidable circumstances.

22. All entries in the tender documents should be in one ink. Bid should be free from correction, overwriting, using corrective fluid, etc.. 2. Vendor must have made at least three times bulk supply of Tea dust (irrespective of Grade and Variety) for minimum quantity of 300 Kgs (each supply) in a financial year on or after 01/04/2019. (Proof to be attached like copy of PO / WO along with proof for supply completion or Vendor invoice along with GST Return copy / proof for receipt of payment as the case may be).
3. The quality of CTC Tea dust (Strength/colour/flavour and taste) will be checked by sample evaluation committee. The committee's recommendation is final and binding.

1. We require approximately 1000 Kilograms of CTC TEA DUST per month conforming to the specification laid out in the Prevention of Food Adulteration Rules 1955 for our Canteens. Kindly refer Clause – 27 of General Terms & Conditions for quantity split up and ordering.
2. Required quantity may vary based on our actual requirement and Quantity mentioned in the purchase order shall be final. BHEL does not guarantee any minimum quantity.
3. Normally the supply should be made once / twice in a month unless otherwise mentioned in the indent.
4. Samples in 2 nos of ¼ Kg in each pack of CTC Tea dust to be submitted along with the techno commercial bid. Samples less than 2 nos of ¼ Kg in each pack will not be accepted.
5. **More than one type of sample will not be accepted.**
6. After opening the technical bid, documents will be verified and the samples would be subject to necessary quality & taste test. The technical bids and samples both found acceptable alone after evaluation will be considered for Price bid opening.
7. The contract shall be awarded for a period of one year from the date of award of contract and supply rate shall remain firm for the entire period of the contract.
8. **Price bid shall be valid up to three months from the date of Tender opening.**
9. **Kindly note that Price bid should be followed by the below mentioned quote and duly signed under.**

1. CTC Tea dust shall confirm to the following analysis:-

2. Vendor should submit the copy of test report of sample within 2 months from award of the contract obtained from CFTRI, Mysore or any one of the NABL accredited food testing laboratory. Payment shall be made on submission of above certificate only.
3. **CTC Tea dust should be supplied in factory bulk pack of 1 (one) Kg only**, which should be in line with the sample given along with the Technical Bid. Expiry date must be mentioned in each Pack.
4. CTC Tea dust shall conform to the standards specified in the "Prevention of Food Adulteration Rules 1955. If needed BHEL may select sample at random from the supplied CTC Tea dust by the successful tenderer for testing the conformity of the supply with the standards specified in the Prevention of Food Adulteration Rules 1955 by CFTRI, Mysore or any one of the NABL accredited food testing laboratory.
5. In the event of the CFTRI, Mysore or NABL accredited food testing laboratory certifying that the sample is NOT CONFORMING with the standards of Prevention of Food Adulteration Rules 1955, the unused CTC Tea dust will be returned to the tenderer. In such a case the rate for the already used CTC Tea dust quantity will not be paid.
6. In case of any defective supply, full quantity is to be replaced by the successful bidder within 2 days' time. Then only the rejected stocks will be returned.
7. CTC Tea dust should be supplied within a month from the date of manufacturing and which can be well utilised for a minimum period of six months from the date of manufacturing.
8. Moreover, any tenderer failing in the quality test by CFTRI, Mysore or NABL accredited food testing laboratory more than once during their supply, suitable action will be taken as per the extant guide lines of BHEL.

General Terms and Conditions

1. The Tenderer may quote fixed rate for a period of one year for the CTC Tea dust to be supplied. The rate should include transport, handling, packing, gunny bag cost, profit margin inclusion of all taxes and delivery at BHEL Canteen stores.
2. The contract will be awarded for a period of one year from the date of award of contract and supply rate shall remain firm for the entire period of the contract.
3. **Price bid shall be valid up to Three months from the date of Tender opening.**
4. BHEL does not guarantee any minimum quantity.
5. **Normally PO will be issued one week in advance through email indicated in the tender enquiry.** Delivery should be made as per PO and any excess materials brought inside the Stores will not be returned at any cost.
6. In case the lowest priced item does not meet the specifications of the tender, BHEL reserves the right not to consider the same.
7. The payment for the supply shall normally be made within 45 days from the date of receipt of CTC Tea dust at BHEL canteen stores and the payment will be made only through EFT mode (Electronic Fund Transfer).
8. The successful tenderer shall report at 08:00 AM and complete the delivery of items as per our delivery schedule at our Canteen Stores on the scheduled date of supply before 11.00 Noon. The delivery schedule will be communicated along with our purchase order to the successful tenderer later.
9. The bulk supply should be made in standard carton box / food grade plastic packing only.
10. It shall be the responsibility of the successful tenderer to weigh the CTC Tea dust properly before loading at their end for supply to BHEL Canteen Stores. Delivery Challan / Credit bill in triplicate should accompany the supply.
11. The successful tenderer shall also arrange his own transport and unload the entire quantity first in the Stores receipt area and after weighing each bag in the electronic balance of HRM Canteen Store and then keep the bags inside the Store room. Delivery of the supply of CTC Tea dust at the Canteen Stores is treated as completed on completion of all above mentioned processes.
12. **The delivery is to be made in BHEL Canteen Stores. In case of failure in supplying the materials as per our Delivery Schedule date indicated in the Purchase Order or replacement not done in time, which will be considered as contract has been breached by the supplier.**
13. The tenderer should possess the correct address of the Firm / Shop, all requisite licenses, Tax Certificates, Registration Documents, etc., for supplying the CTC Tea dust.
14. Offer submitted late beyond the due date & time will be summarily rejected. Submitting more than One (1) type of sample will be also summarily rejected.

15. All the entries in the tender documents should be in one ink. Erasing and overwriting are not permitted. Cancellations and insertions, if any shall be authenticated by the tenderer by signing affixing his seal. After submitting the tender, the tenderer is not entitled to recall his/its offer of modify the terms and conditions thereof.
16. These general terms and conditions shall be applicable for the bids, however BHEL reserve rights to add, cancel or modify the same at any time without assigning reasons.
- 17. BHEL reserves the right to**
- I. Increase or decrease the tendered quantity.
 - II. Cancel the tender enquiry at any stage or cancel the contract at any time during the execution of contract without assigning any reason
 - III. Negotiate or re-float the tender opened if L1 price is not the lowest acceptable price to them inter-alia other reasons. The decision of BHEL in awarding the contract is final and BHEL reserves the right to reject any or all tenders without assigning any reasons.
 - IV. In case more than one bidder happens to occupy L-1 status, effective L1 will be decided by soliciting discounts from the respective L1 bidders. In case more than one bidder happens to occupy the L-1 status even after soliciting discounts, the L-1 bidder shall be decided by a toss / draw of lots, in the presence of L-1 bidders or their representatives (In the event of non-availability of L1 bidder or bidders, BHEL will decide by toss / draw of lots). Ranking will be done accordingly. BHEL's decision in such situations shall be final and binding.
18. Disputes or differences arising from this tender or in any manner connected therewith, Head of HR's decision of BHRL, Tiruchy is final and binding.
- I. Any dispute shall initially be discussed amongst parties and settled amicably.
 - II. If no amicable settlement or if there is no scope for amicable settlement, then any party may refer the dispute to sole arbitrator to be nominated by the Head of HR, BHEL, Trichy. The place of arbitration shall be at Trichy. All arbitration proceedings shall be conducted in English in accordance with the provisions of the Arbitration and Conciliation Act, 1996.
 - III. The arbitration award shall be final and binding upon the parties and each party will bear its own costs of arbitration and equally share the fees of the arbitral tribunal.
19. All disputes shall be subject to the exclusive jurisdiction of courts at Trichy.

20. Breach of contract, Remedies and Termination

In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is 10% of the contract value or more, such security instruments to the extent of 10% contract value will be encashed. In case no security instruments are available or the value of the security instruments available is less than 10% of the contract value, the 10% of the contract value or the balance amount, as the case may be, will be recovered in all or any of the following manners:

- a. from dues available in the form of Bills payable to defaulted supplier against the same contract.
- b. from the dues payable to defaulted supplier against other contracts in the same Region/Unit /any other region/unit
- c. In-case recoveries are not possible with any of the above available options, Legal action shall be initiated for recovery against defaulted supplier.
- d. In case Vendor fails to fulfil any of the specified terms and conditions of PO / contract then, the PO/Contract shall be cancelled / short closed and appropriate cost shall be deducted from the vendor's pending bills in BHEL Trichy (or) across the BHEL units.

Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc. will be applied as per provisions of the contract.

21. Liquidate Damages

If the supplier fails to deliver / complete the replacement of the materials (in case of quality issue) within 15 days from the date of issue of PO, Liquidated Damages of a sum equivalent to 0.1% of the PO value per day will be deducted from the supplier subject to maximum of 10% of contract value. **BHEL will have the right to consider as contract has been breached in case of failure in completion of supply within 15 days.**

22. Termination of Contract on Death of Contractor:

Without prejudice to any of the rights or remedies under this contract, if the Contractor dies, or if the firm is dissolved or the company is liquidated, BHEL shall have the option of terminating the contract without compensation to the Contractor.

23. Arbitration: -

Disputes or differences arising from this tender or in any manner connected there with shall be subject to the following dispute resolution mechanism:

1. Any dispute shall initially be referred to the designated Senior Management of the parties for amicable settlement. Parties shall nominate two persons each from their senior management within 10 days of a dispute arising.
2. If no amicable settlement is arrived at within 30 days, then any party may refer the dispute to sole arbitrator to be nominated by the Head of HR, BHEL, Trichy. The place of arbitration shall be at Trichy. All arbitration proceedings shall be conducted in English in accordance with the provisions of the Arbitration and Conciliation Act, 1996.

3. The arbitration award shall be final and binding upon the parties and each party will bear its own costs of arbitration and equally share the fees of the arbitral tribunal. All the disputes shall be subjected to the exclusive jurisdiction of courts at Trichy.

24. Fraud prevention policy:

- The bidder along with its associate / collaborators / sub-contractors / sub-vendors / consultants / service providers shall strictly adhere to BHEL fraud prevention policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL management about any fraud or suspected fraud as soon as it comes to their notice.
- Fraud Prevention Policy and List of Nodal officers shall be referred on BHEL Website, Vendor Portals of Units/Regions intranet.

25. SUSPENSION OF BUSINESS DEALINGS WITH SUPPLIERS / CONTRACTORS:

Penal action can be initiated on the suppliers / Contractors in line with extant 'Guidelines for Suspension of Business Dealings with Suppliers/ Contractors. The abridged version of extant 'Guidelines for suspension of business dealings with suppliers/ contractors' has been uploaded on <http://www.bhel.com> on "supplier registration page".

26. SPECIAL PROVISIONS FOR MICRO AND SMALL ENTERPRISES (MSE)

BIDDERS REGISTERED AS PER MSME ACT:

1. Minimum of 25% of the tendered quantity is earmarked for MSE Vendors (Manufacturers only) as per the latest MSE guidelines. Since the contract can be awarded to maximum of Two vendors for convenient handling, ordering will be on maximum of Two source only. If L1 offer is from a Micro / Small enterprise, this provision is not applicable.
2. In case of L1 offer is from Non MSE, Eligible MSE vendors will be allowed to supply the portion of the requirement subject to acceptance of L1 price by MSE vendor. In case of more than one such MSE, the rate will be counter offered to MSE vendor on the order of their commercial ranking. In case of MSE vendor falls on the same ranking, draw of lots or Toss will be followed to decide the ranking.
3. **For availing MSE benefit, MSE vendor under manufacturer for tendered items should submit copy of Udyam Registration number along with Technical bid.**
4. Non submission of such documents will lead to consideration of their bids at par with other bidders and MSE status of such suppliers shall be shifted to Non MSE supplier till the supplier submits these documents. This provision for MSE will apply subject to the condition that the participating MSE meets the tender requirements.
5. In case of any change in the MSE status of the bidder, it shall be the responsibility of the bidder to notify the change as a part of the bid document. If at a later date it comes to the knowledge of BHEL, that the change in the status has not been intimated by the bidder and the order is obtained under the premise of an MSE then BHEL would cancel the pending order against this tender and take necessary steps for suspension of the business dealing with the bidder as per the procurement policy of BHEL.

27. Ordering will be done as mentioned below (MSE clause as well as split of total quantity applicable):

- a) In case L1 is MSE vendor, Special provision for MSE vendor is not applicable. 60% (approximate) will be ordered on L1 Vendor and 40% (approximate) will be counter offered to L2, L3 etc. vendor who matches L1 price based on rank i.e. 1st it will be offered to L2 Vendor, if accepted 40% will be ordered and in case not accepted by L2 vendor then it will be counter offered by L3 vendor and so on excepting H1 vendor.
- b) In case L1 is non MSE, 60% (approximate) will be ordered on L1 vendor and balance 40% (approximate) will be awarded to eligible MSE vendor who matches the L1 price. The preference to the MSE vendors will be given in order of their ranking L1, L2, L3, etc. In case more than one MSE vendors falls on same ranking, the ranking will be decided by a toss / draw of lots, in the presence of MSE bidders or their representatives (In the event of non-availability of MSE bidder or bidders, BHEL will decide by toss / draw of lots).
- c) If there is no response from MSE vendors or if there are no eligible MSE vendors or none of the eligible vendors accepted the L1 rate, then L1 rate will be counter offered to other vendors on commercial rank basis excluding H1 vendor.
- d) In case none of the participating vendor is MSE vendor, 60:40 sharing will be followed.
- e) In case of L1 counter offering rate has not been accepted by any of the vendor, such counter offered quantity also will be ordered on L1 vendor.

28. Conflict of interest –

A bidder shall not have conflict of interest with other bidders. Such conflict of interest can lead to anti-competitive practices to the detriment of procuring entity's interests. The bidder found to have a conflict of interest shall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:

- a) they have controlling partner (s) in common; or
- b) they receive or have received any direct or indirect subsidy / financial stake from any of them; or
- c) they have the same legal representative/agent for purposes of this bid; or
- d) they have relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another bidder; or
- e) Bidder participates in more than one bid in this bidding process. Participation by a bidder in more than one bid will result in the disqualification of all bids in which the parties are involved. However, this does not limit the inclusion of the components / sub-assembly / assemblies from one bidding manufacturer in more than one bid; or

- f) In cases of agent quoting in offshore procurement, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/dealer. There can be only one bid from the following:
- 1) The principal manufacturer directly or through one Indian agent on his behalf; and
 - 2) Indian/foreign agent on behalf of only one principal;
- g) A bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the contract that is the subject of the Bid; or
- h) In case of a holding company having more than one independently manufacturing units, or more than one unit having common business ownership / management, only one unit should quote. Similar restrictions would apply to closely related sister companies. Bidder must proactively declare such sister / common business / management units in same / similar line of business.
