#### **TERMS & CONDITIONS**

### (1) Earnest Money Deposit:

Each Tender must be submitted together with a Demand Draft for the value specified against each shop (given in ANNEXURE – A) drawn on any Nationalized Bank in favour of "Bharat Heavy Electricals Limited, Tiruchirappalli-14" payable at Tiruchirappalli-14 towards Earnest Money Deposit (EMD). Tenders received without Earnest Money Deposit shall be summarily rejected. Cheques will not be accepted. The Demand Draft towards EMD amount may be kept in a separate envelope.

Earnest Money deposit of unsuccessful tenderers shall be refunded after expiry of validity period of the tender. #### (2) Security Deposit:

- (3) Selection of successful Bidder shall be made by a Tender Committee appointed by BHEL. The technical bid will be opened on the specified date and the tenderers will be evaluated to find the suitability. The financial bids of the technically accepted offers will be opened on a date to be specified later. - (5) The successful tenderer shall have necessary licence as required by Govt. authorities/statutory authorities for running the proposed shop.
