1. THE TENDER IS TO BE PROCESSED IN TWO PARTS VIZ. TECHNICAL BID AND PRICE/RATE BID. THE TECHNICAL BID APPLICATION (ANNEXURE - H) AND ITS ENCLOSURES ALONG WITH THE CONTRACTOR'S OBLIGATIONS, OTHER GENERAL TERMS & CONDITIONS MUST BE SUBMITTED IN ONE SEALED ENVELOPE SUPER SCRIBED AS **“LOADING/UNLOADING OF MATERIAL AND OPENING AND SHIFTING OF WOODEN PACKING BOXES IN MAIN STORES TO & FRO TRUCK,TEMPO AND TRAILER.” - TECHNICAL BID.**

**TENDER EVALUATION CRITERIA**

The evaluation of the Tender will be carried out as follows:

1. The tenders confirming to the Notice Inviting Tender, Qualifying requirements, Instructions to the Tenderers, Contractor's obligations, Other General Terms and Conditions, Technical and Price bids conditions only will be evaluated.
2. Such of those tenders which confirm to the technical bid (Annexure - H) only will be evaluated.
3. Successful tenderers after the above process only will be invited for opening of the rate / price bid.
4. The tenderer who quotes the cumulative lowest rate/price will be awarded the contract.

CONTRACTOR'S OBLIGATIONS

A) CONTRACTUAL

Towards selection, control and supervision of employees

- a) **Contractor shall decide the number of employees to be deployed** for execution of the work awarded to him and he or his authorized representative will be solely entitled to dictate such workers about the manner of carrying out the work as per the prescribed specifications and quality plan.
- b) Contractor **shall supervise the work** allotted to him and to be carried out by his employees.
- c) Contractor to ensure that the employees deployed in the premises of BHEL **are physically and mentally fit and do not have any criminal record**. Such employees should **possess requisite skill, proficiency, qualification, experience etc.**
- d) Contractor **will keep watch on his employees and he will be liable for any pilferage / loss to BHEL** due to acts of omission and commission by his employees. Similarly, liability for any compensation to outsiders on account of any act of omission and commission by the employees deployed by the contractor shall lie exclusively with him.
- h) Contractor to ensure that **all precautions are taken for safety** of his employees and equipments.
- i) In the event of termination of contract for any reason whatsoever, the **contractor shall withdraw all his employees** from the establishment of BHEL. In case contractor decides to terminate services of his employees. **He should settle all terminal dues.**

B) Towards supply safety equipment and appliances

Contractor shall **provide safety appliances and maintain the same** at his own cost, which may be required under the statute or otherwise.

C) Towards statutory liability

- a) As mentioned in the terms and conditions enclosed as Annexure 'G' of this contract.

- b) Contractor shall indemnify BHEL against all claims by statutory authorities and loses under various Labour Laws, statutes or any civil or criminal law in connection with employees deployed by him.

**D) Towards Finance**

***Contractor is to arrange his own finance*** for carrying out the job including payment of wages to his employees. ***Rates quoted shall be net and inclusive of all the capital cost, material cost, taxes and levies*** which might be applicable to this type of job. Service tax shall be extra.

**OTHER GENERAL TERMS & CONDITIONS FOR CONTRACTORS FOR DEPLOYMENT OF LABOURS UNDER WORKS/SERVICE CONTRACT.**

Works contracts shall only be awarded for the works on the following terms and conditions.

1. Rates will be firm and fixed for a period of one year from the date of finalisation of contract, which may be subsequently extended with mutual agreement. However the contract shall be liable for early termination at any time giving 30 days notice.
2. Contractor will carry out loading/unloading of material as and when advised by Stores Incharge of BHEL.
3. Contractor will engage adequate number of persons to carry out the above mentioned jobs within stipulated time frame.
4. Bills for work done will be raised by contractor for job done during each month based on work certified by Main Stores of BHEL
5. Security Deposit of 10% will be deducted from contractor's each bill which will be refunded to the contractor at the end of successful completion of contract for the stipulated period. In case contractor refuses to work for the entire period of contract this amount shall stand forfeited. However if BHEL decides to terminate the contract before expiry of contract period, this amount shall be refunded to the contractor.
6. Normally the jobs of loading and unloading of material will be carried out by the contractor during normal working hours of BHEL unless otherwise permitted by BHEL to work beyond working hours. BHEL on its own may ask the contractor to work beyond office hours and even on holidays to meet emergency situations.
7. Rates of loading and unloading of material should be quoted on per MT basis. Weight mentioned in weighment slip shall be taken as authentic weight. In case of any dispute decision of Main Stores Incharge shall be final.
8. Separate rate shall be quoted for opening and shifting of wooden boxes.
9. Approximate Annual Load for unloading/loading is about **6000 MT**. Normally quantum of work may increase during the last quarter of financial year. Contractor will have no claim whatsoever on account of idle manpower due to non-availability of load, break down, cranes etc. No minimum charges will be payable for above works. Charges will be worked out on basis of actual work done per month.
10. Contractor will ensure that BHEL materials and facilities are utilised properly and optimally to minimise wastage and job is done as per BHEL's requirement and time schedules.
11. Single package or item that weighs upto 100 Kgs will be handled manually. For heavier packages or items, BHEL will provide forklifter/crane, depending upon the availability.
12. In case of any dispute, the decision of Head MM, BHEL, shall be final and binding on the contractor. The contractor will be liable for any damage or loss to the work premises or facilities or property of BHEL caused due to negligence of his workmen and shall have to duly compensate for the same at his own cost.

13. Company shall have no direct responsibility/ liability whatsoever in respect of the workmen engaged by the contractor for the above works. Necessary insurance of employed labour as per F.A. 1940 shall be the responsibility of the contractor.
14. Contractor or any person engaged by him will not be entitled for any employment in this organisation or any other benefits or compensation.
15. No child labour will be engaged by the contractor during the execution of the contract. Statutory obligations will have to be met by the contractor himself.
16. Tools and protective equipments like gloves, safety shoes etc. required by the labour will be provided by the contractor.
17. No free tea, snacks and meals will be provided by BHEL. However as canteen facility is available in BHEL, your labour, may avail the canteen facility on payment basis.

GENERAL TERMS AND CONDITIONS: -

- 10.10 In case of non-satisfactory performance of the contract, BHEL shall have a right of forfeiting the security deposit. In case of any dispute, decision of concerned Head of the Department will be final.
- 10.11 The work shall be supervised by the contractor or through the authorized representatives on day-to-day basis.
- 10.12 The Contractor shall compensate BHEL for any loss or damage to the plant/property, material of BHEL due to his workmen/representatives' negligence or otherwise during execution of work.
- 10.13 In the event of contractor abandoning the work or BHEL revoking the contract BHEL shall have a right to get incomplete work completed at contractor's risk and cost.

11.3 JURISDICTION :-

Any other of dispute arising out of or in connection with this contract shall be under jurisdiction of Tarn Taran only.
