## Section-I

### Specification for Foot operated shearing Machine

With reference to above indent, the technical specification shall be as follows:-

1. The machine should be Foot operated suitable for cutting the steel strips of size **305mm x 30 mm x 1.5mm from 1500mm wide sheets.**
2. The machine should be capable of shearing the strips with less than 40 microns burrs at the sheared edges.
3. One set of spare blades to be supplied along with the machine.
4. The erection and commissioning shall be in the scope of the supplier.

**Note: 1. Spares & tools shall be supplied with Shearing Machine.**

**2. Erection & commissioning of the machine at CSU, Jagdishpur.**

## Section - 2

### Commercial conditions

1. The prices are firm and inclusive of all taxes, duties, freight, Insurance charges. Supplier will submit billing breakup along with the offer
2. Excise duty and CST against form 'C' will be payable at actual.
3. TIN No will be submitted by supplier.
4. The consignment shall be supplied FOR, BHEL, CSU Jagdishpur, Dist. Sultanpur, UP-PIN-227817.
5. Date of receipt at BHEL, Jagdishpur works shall be treated as date of delivery.
6. **Delivery** – Within **Four weeks** from issue of PO/LOI.
7. **Delivery Terms**:- F.O.R -CSU Jagdishpur
8. **Warranty Certificate:** Warranty certificate shall be provided with material for 12 months from the date of acceptance
9. **Acceptance**: The equipment shall be accepted after successful Erection & commissioning at CSU, Jagdishpur.
10. **Terms of Payment**:
  - i) 80% of basic plus with 100% of taxes, duties freight & insurance charges shall be Paid on receipt and balance 20% after acceptance of equipment.
  - ii) All bank charges shall be to vendor's account.
  - iii) Supplier should submit the original tax invoice.

iv) Supplier should mention their TIN no. on the bill.

11. **Penalty for Delay**

- (i) The delivery of equipment shall be made within the time prescribed. Failure to dispatch the equipment in time as per the delivery specified above would make the vendor liable to an un-conditional penalty at the rate of one half percent (1/2%) of the order value for delay of each week (or part thereof) Subjected to a maximum of ten percent (10%) of the order value.

12. **Invoices and payment documentation**

- (i) Invoices shall be issued by the supplier in the name of the purchaser.  
(ii) The invoices shall contain the following information:  
A. Item no. quantity and description of equipment as per purchase order.  
B. Gross amount payable and net amount payable.  
C. Taxes and duties payable.  
D. Tax Registration No.  
(iii) The following documents shall be presented by the supplier to the purchaser for drawing payment:  
A. Signed commercial invoice in quadruplicate.  
B. Packing List.  
C. LR or equivalent document.

13. **Rejections:** The supplier shall arrange replacement/repair within one month from the date of rejection intimation upon failure on supplier's part to comply. BHEL will take whatever appropriate action they may think fit in addition to repair/return of rejected equipment at the cost and risk of the supplier.

14. **Risk purchase:** In case of delays in supply of equipments/defective equipments not fulfillment of any other terms and conditions given in the purchase order, the purchase may cancel the full or part thereof, and may also make purchase of such equipment from elsewhere/alternate source at the risk and cost of supplier.
