PRE QUALIFICATION

 - (b) **P. F. Code No:** Copy to be enclosed
- 2 Labour licence (Central Government) before commencement of work.
- 3 **PAN No .:** Copy to be enclosed
- 4 **It is required to furnish VAT registration certificate issued by Commissioner,** Commercial taxes, AP Govt, in respect of all works costing more than Rs. 5.00 lakhs each.
6. **Service Tax registration no:** in case not available, proof of having applied with acknowledgement from concern authorities
7. Period of completion shall be as mentioned in NIT.
