## PRE QUALIFICATION

- 1 Particulars of experience for the works executed of similar nature (Completion/Executed certificates to be enclosed). Shall have experience of execution of above works as per the pre-qualification criteria in technical bid. **Similar works:** As mentioned in the technical bid.
  - (a) **ESI code :** (The agency has to attach the proof if not available agency should submit the application Acknowledgement receipt from ESI).
  - (b) **P. F. Code No.**
- 2 Labour licence (Central Government) before commencement of work.
- 3 **PAN No.**
- 4 **APGST** (in case not available, proof of having applied with acknowledgement from concern authorities) (**It is required to furnish VAT registration certificate issued by Commissioner**, Commercial taxes, AP Govt, in respect of all works costing more than Rs. 5.00 lakhs each).
6. **Service Tax registration no:** in case not available, proof of having applied with acknowledgement from concern authorities
7. Period of completion shall be as mentioned in NIT.
8. Penalty: 0.50 % of the gross value of work will be levied for every weeks delay by the agency subject to a maximum of 10 % value of the work.
